PREAMBLE

The Food and Agriculture Organization of the United Nations (FAO) is a specialized agency of the United Nations system with a mandate to: eradicate hunger, food insecurity and malnutrition; eliminate poverty; promote progress in the form of economic and social development; and foster the sustainable management and utilization of natural resources for the benefit of present and future generations. FAO produces an abundance of expert information and knowledge through its technical and applied work. In order to make that body of knowledge accessible to users worldwide, the Organization encourages the wide use, reproduction and dissemination of all intellectual property produced by FAO, including works prepared by other organizations under contract with FAO.

OPEN ACCESS RATIONALE

Open Access can be defined as the immediate, irrevocable and free online access to information products by any user worldwide, and re-use that is free of most restrictions, subject to proper attribution. FAO considers Open Access to be an important practical application of its commitment to the collection, synthesis, packaging and distribution of FAO knowledge to the world at large, and particularly the populations of those countries where such knowledge may not be readily accessible.

This policy advocates the application of suitable open licenses to FAO copyright material in accordance with the principles of openness and sharing envisioned under Open Access, and consistent with the mandate of FAO.

This policy complies with and extends the [FAO Corporate Communication Policy](#); the [FAO Corporate Publishing Policy](#); the [Publishing at FAO – Strategy and Guidance](#) document and the [FAO Logo Policy and Guidelines](#).

FAO OPEN ACCESS POLICY

1. SELF-ARCHIVING

All FAO publications and documents that are free of restrictions must be archived in the FAO Document Repository. In the case of FAO articles published in non-FAO publications, FAO retains copyright over the content of the article while granting the publisher a license to publish the final product. In these cases, FAO, as copyright holder, must always retain the right to publish the content of the Pre-print/Accepted Author's Manuscript version of the article in the FAO Document Repository.

2. OPEN ACCESS JOURNALS

In addition to self-archiving, FAO authors¹ may elect to publish articles in Open Access journals provided by commercial publishers. Open Access delivered by journal publishers is sometimes referred to as Gold Open Access. Note that commercial publishers require the authoring institution to pay a fee for the right to make these products available in Open Access.

The Creative Commons license will be displayed on the published version of the article according to the guidelines of the journal publisher. The FAO copyright symbol and author disclaimer² must also appear on all FAO articles published in non-FAO journals.

3. CREATIVE COMMONS LICENSING

As of 18 June, 2018, FAO will apply a Creative Commons 3.0 Intergovernmental Organization (IGO) license to all eligible publications and documents under FAO copyright and published on www.FAO.org. This Creative Commons license may also apply to the content of FAO-authored journal articles published by external, non-FAO publishers. Examples of items that are not eligible for Creative Commons licenses are those where copyright is shared with another institution that is not able to comply with Open Access requirements, and materials that are subject to restrictions, i.e., member country restrictions or publications where only one official language translation may legally exist.

A Creative Commons license applies to an FAO information product if that product displays a Creative Commons license on its copyright page (or front page in the case of products that do not include a copyright page).

The default license that will apply to FAO information products is:
Creative Commons Attribution-NonCommercial-ShareAlike 3.0 IGO (CC BY-NC-SA 3.0 IGO).

Creative Commons licenses will not be applied retrospectively to FAO publications or documents published before 18 June, 2018.

4. _____ RELATIONSHIP OF COPYRIGHT TO CREATIVE COMMONS LICENSES

FAO, like other UN agencies, retains copyright of all intellectual property that it produces or that is produced on its behalf. This is a protective measure, to ensure that FAO always has the right to freely disseminate this material to its members and stakeholders, and to ensure that no other entity is able to make unauthorized re-use of FAO intellectual property for profit-making purposes or any other corporate advantage.

FAO does not forfeit its right to copyright ownership, and it does not transfer this right to other entities. Creative Commons licenses should not be considered a substitute for copyright ownership. Instead, Creative Commons licenses are a useful tool for managing copyright; providing a means for FAO to state the terms and conditions for using FAO copyright material according to standards that are commonly understood and frequently applied throughout the publishing industry.

5. _____ RESPONSIBILITIES

FAO Departments and Decentralized Offices are responsible for:

- Liaising with OCC to negotiate licenses for book chapters/articles published by non-FAO publishers.
- Paying Open Access fees for Gold Open Access.
- Creating records for all FAO publications in the Publications Workflow System.
- Ensuring that all external publishers receive a copy of FAO's signed license agreement before publication.
- Ensuring that the Pre-print/Accepted Author's Manuscript versions of all FAO articles published by external publishers are published in the FAO Document Repository.
- Ensuring that all non-FAO contributors are aware of FAO's Open Access Policy, and that they have agreed in writing to either transfer copyright ownership of their contribution to FAO, or have granted FAO a license to disseminate their contribution as part of a larger work owned by FAO.

FAO's Office for Corporate Communication (OCC) is responsible for:

- Ensuring appropriate copyright protection for all intellectual property produced by FAO or on its behalf as a work for hire.
- Providing support and documentation to Departments and Decentralized Offices to ensure that all external publishers receive FAO's signed license agreement.
- Ensuring that all non-restricted FAO intellectual property is published in the FAO Document Repository according to Open standards, ensuring freedom of access to all, and the preservation of FAO institutional memory for posterity.

All parties reusing FAO copyright material must:

- Request permission from: copyright@fao.org for any commercial reuse of FAO copyright material.
- Ensure that they have obtained permission to reuse any third-party, non-FAO material (such as tables, figures and images) that may appear in FAO information products.

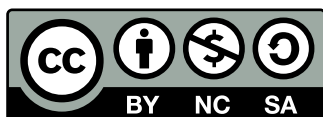
