I. INTRODUCTION

1. The *Open-ended Working Group on the Rules of Procedure and Financial Rules of the Governing Body, Compliance, and the Funding Strategy*, which met in Rome, Italy, from 14 to 17 December 2005, reviewed and revised a draft Resolution on the Funding Strategy, to which the draft Funding Strategy is annexed, and recommended that they be submitted to the Governing Body for consideration at its first session. This is contained in the document *Draft Funding Strategy of the International Treaty*.¹
2. The Open-ended Working Group agreed that further views on, and suggested text for, the Funding Strategy could be submitted, and requested the Interim Secretariat to compile such views and suggested text, for consideration as a background document by the first session of the Governing Body.
3. On 27 January 2006, a Circular State Letter was issued, inviting countries to submit further views on the Funding Strategy of the Treaty to the Secretariat (*Appendix*). At the time of preparing this document, submissions had been received from Algeria, Argentina, Australia, Burkina Faso, Egypt, Ethiopia, the European Union, Guinea, Honduras, Indonesia, Lithuania, Madagascar, Morocco, Nepal, Pakistan, Panama, Peru, Syria, Uruguay and Zambia. They were posted on the Commission's website, at <http://www.fao.org/ag/cgrfa/compfs.htm>. Submissions received after the preparation of this document are also posted on the Commission's website.

II. COMPILATION OF FURTHER SUBMISSIONS

4. These further views have been compiled in the tables below.² A number of countries made more general comments. These have not been incorporated in the tables. New text or modification to the document *Draft Funding Strategy of the International Treaty*³ as proposed by countries, or where they have indicated preference(s) from available options, has been reflected in the tables. This is presented in *italics* with the modifications to current text reflected in ***bold italics***.
5. The Governing Body is invited to take these submissions into account, as appropriate, in considering the draft Resolution the Funding Strategy.

ANNEX 1: Priorities for the Use of Resources under the Funding Strategy PROGRAMMES

1. Survey, collection and inventory of PGRFA, including
 - assessing the status and degree of variation in existing populations, including those of potential use for food and agriculture
 - developing monitoring and early warning systems for the loss of PGRFA
 - minimizing or, if possible, eliminating threats to PGRFA.
2. *Ex situ* management and conservation of PGRFA, including
 - developing and strengthening facilities for conservation of PGRFA
 - regenerating threatened *ex situ* accessions
 - improving collection management, education and training
 - promoting the development of efficient and sustainable *ex situ* conservation, with adequate information systems, documentation, characterization, regeneration and evaluation
 - supporting collection activities of valuable or threatened PGRFA
 - promoting the development and transfer of appropriate management, conservation and regeneration technologies
 - monitoring the maintenance of the viability, degree of variation, and genetic integrity of collections of PGRFA.
3. *In situ* management and conservation of PGRFA, including
 - supporting efforts to manage and conserve on-farm PGRFA
 - promoting conservation of wild crop relatives and wild plants for food and fibre production
 - promoting the conservation of local knowledge associated with *in situ* conservation and development of PGRFA.
4. Research and breeding to strengthen diversity, including
 - strengthening the capacity to develop varieties adapted to specific conditions,
 - broadening the genetic base of crops and increasing the range of intra- and inter-specific diversity available to farmers
 - enhancing international activities to promote conservation, evaluation, documentation, genetic enhancement, plant breeding, seed multiplication and sharing of PGRFA
 - providing access to and exchanging PGRFA and appropriate information and technology.
5. Capacity building, including
 - establishing and strengthening programmes for scientific and technical education and training in conservation and sustainable use of PGRFA
 - establishing or strengthening national capabilities to conserve and use PGRFA sustainably
 - promoting the provision of technical assistance in these areas
 - carrying out scientific research preferably, where possible, in developing countries and countries with economies in transition, in cooperation with scientific institutions in those countries.
6. Enhancing crop diversity, including
 - promoting the expanded use of local and locally adapted crops, varieties and underutilized species, and the commercial use of a wider diversity of varieties and species in order to reduce crop vulnerability and genetic erosion.
7. Increasing public awareness, including

- **promoting public awareness of the Treaty, its Multilateral System and the value of the conservation and use of PGRFA.**

ANNEX 2: Use of Resources under the Direct Control of the Governing Body – Eligibility Criteria

Resources under the direct control of the Governing Body should be allocated to Projects under the Funding Programmes (see Annex 1) established by the Governing Body. The significance of the problem identified and the probability of meeting Treaty objectives and priorities will be criteria in determining resource allocation to a particular Project proposal.

Each Project proposal will need to identify

- **the expected output(s),**
- **target region(s) or groups,**
- **beneficiaries and/or intended users and**
- **the intended beneficial changes that will result.**

Users are those whose knowledge of, use or adoption of the Project output should lead to beneficial change directly related to the objectives and priorities of the Treaty.

The capacity of those proposing projects to achieve their intended outputs will be one of the criteria used in selecting Projects for funding. Collaborative Projects that leverage funding from other sources to address Treaty objectives will also be an important consideration in the selection process. The effectiveness of the resources available to the Treaty can be assisted if

- **other funding sources can be harnessed, via joint projects, and**
- **if similar project proposals can be combined to enhance the expected achievement of outputs.**

ANNEX 3: Use of Resources under the Direct Control of the Governing Body – Operational Procedures

The funding target established by the Governing Body under paragraph 18.3 of the Treaty is underpinned by a five year rolling Medium Term Funding Plan, which allows allocations to be reviewed and adjusted in the context of the Funding Strategy and its funding priorities.

The Funding Plan will need to be consistent with the likely available resources. Funding priorities have to be established to cope with the contingencies of less or more resources than anticipated. The Funding Plan, once approved by the Governing Body, is eligible for financing by Parties, other governments and other donors, as well as through the resources available to the Governing Body.

Funding allocations are made to Projects, assessed by the Funding Sub-Committee and approved by the Governing Body. Each Project has to be fully costed. Projects need to be output focussed, with explicit links from these outputs through outcomes to measurable impacts – the ultimate benefits arising from the funding allocation. Projects are organised within Programmes that address the priorities established by the Funding Strategy (See Annex 1).

Each Project proposal needs a detailed rationale that sets it within the context of the Treaty and the Funding Strategy. It needs a problem analysis statement and a proposed solution to a problem identified in the Funding Strategy's priorities. It needs a commentary on why this funding has advantages over similar, comparable allocations by others, and identification of the expected output(s), target region(s) or groups, beneficiaries and/or intended users and resulting beneficial changes. (Users are those whose knowledge of, use or adoption of the output should lead to beneficial change directly related to the objectives and priorities of the Treaty). An estimate of the magnitude of uptake of the output, and the difficulties of achieving this, has to be included.

A plausible pathway from the output to the impact(s) that meet the Treaty's objectives and priorities has to be included. The role of the funding in terms of the Treaty being a primary or secondary contributor, catalyst, facilitator, or advocate has to be described. The funding and other contributions and the role of partner organisations have to be elaborated, along with the output(s) to which they are committed. Each Project has to specify annual Output Targets - the quantity and type of measurable, verifiable benefits expected. These Output Targets can include policies, strategies, changes in practice, improved sustainability, capacity improvements, infrastructure improvements, training, knowledge, and materials conserved.

At the conclusion of each Project, audited financial statements that comply with the International Financial Reporting Standards issued by the International Accounting Standards Board will be provided to the Funding Committee and the Evaluation & Audit Committee of the Governing Body.

ANNEX 4: Use of Resources under the Direct Control of the Governing Body – Modalities of a Strategy to Promote Voluntary Contributions

The Governing Body will appoint a Voluntary Contributions Committee made up of experts to promote voluntary contributions on its behalf.

The Governing Body will commission this Committee, in consultation with the secretariat, to prepare on a regular basis a paper for its consideration that sets out options for a strategy to promote voluntary contributions, drawing on the experience of member Governments, FAO and other organisations in similar exercises.

To assist it in its task, the Governing Body will advise the Voluntary Contributions Committee of

- **the extent of funding required, based on the funding target established by the Governing Body,**
- **the priorities for the distribution of funds,**
- **the long term strategy for maintaining funding flows,**
- **the anticipated administrative costs and the strategies to minimise them,**
- **the proposed oversight mechanisms for the receipt and distribution of funds and other governance mechanisms,**
- **the evaluation procedures, and**
- **the annual reporting procedures.**

The Committee's paper should outline the various objectives and/or programs that are proposed to be funded, and the optimal level of funding sought.

This paper should form an attachment to a letter circulated to governments, companies, foundations, NGOs and other potential contributors, seeking their assistance by making voluntary contributions.

ANNEX 5: Information and Reporting Requirements under the Funding Strategy

The Governing Body will establish a performance management reporting system that specifies the detail required on the achievement of Project outputs and of any deviation from the activities, timetables and targets previously advised.

The Governing Body will be advised from time to time of

- **the relevant international mechanisms, funds and bodies,**
- **their objectives,**
- **how these objectives relate to those of the Treaty,**
- **the level of funding as well as current and proposed programs under those mechanisms that may meet the objectives of the Treaty,**
- **the current and proposed arrangements for collaboration with those mechanisms, and**
- **the plans and programs that are proposed to be implemented under the Treaty in conjunction with those international mechanisms, funds and bodies.**

Gaps and overlaps between the Treaty's programme and those of other mechanisms will need to be clearly identified.

ANNEX 6: Targets for funding

The Governing Body will, from time to time, consider options for funding targets, focussing on the near term, i.e. the following three years, and the priorities that should be attached to each option in terms of the extent of programme delivery.

The Director-General of the Food and Agriculture Organization of the United Nations has the honour to refer to the International Treaty on Plant Genetic Resources for Food and Agriculture, which was approved by the FAO Conference at its Thirty-first Session in November 2001, through Resolution 3/2001, in accordance with Article XIV of the FAO Constitution. The Resolution also requested the Commission on Genetic Resources for Food and Agriculture to act as Interim Committee for the Treaty, and prepare the First Session of the Treaty's Governing Body, which is scheduled to be held in Madrid from 12 to 16 June 2006, at the kind invitation of the Government of the Kingdom of Spain.

At its Second Meeting the Interim Committee established an Open-ended Working Group on the Rules of Procedure and Financial Rules of the Governing Body, Compliance and the Funding Strategy. The Open-ended Working Group met in Rome from 14 to 17 December 2005 and took a number of decisions.

Article 21 of the Treaty, Compliance, requires the first meeting of the Governing Body of the Treaty *"to consider and approve cooperative and effective procedures and operational mechanisms to promote compliance with the provisions of this Treaty and to address issues of non-compliance"*. During the meeting of the Open-ended Working Group countries and regions made comments and submissions on the issue of compliance, which were consolidated in the text in *Appendix 1* to this letter. The Open-ended Working Group *"invited further submissions and comments by countries and regions, including on the text [in Appendix 1], and requested the Secretariat to post these on the Commission's Web-site"*.

Article 19.3c requires the Governing Body *"to adopt, at its first session [...] the funding strategy for the implementation of this Treaty, in accordance with the provisions of Article 18"*. The Open-ended Working Group considered and revised a draft Funding Strategy, including a draft Resolution, for submission to the Governing Body.

... The revised draft Funding Strategy and draft Resolution are attached as *Appendix 2* to this letter. The Open-ended Working Group also *"agreed that Members might provide the Secretariat with further views on, and text for, the Funding Strategy, by 31 March 2006. It requested the Secretariat to compile such views and suggested text for consideration as a background document by the first Session of the Governing Body"*.
