1. The FRA 2010 Country reporting process

The deadline for the submission of the FRA 2010 final draft Country Reports was the end of May 2009. We would like to thank, once again, all the National Correspondents for all the support provided to the FRA 2010 Reporting process. The degree of participation, the dedication to the reporting process and the level of response, have been beyond expectations.

Thanks to the crucial contribution of the National Correspondents network, we have to date a total of 208 cleared reports. For those countries that did not provide any reports the FRA secretariat prepared a number of desk studies based on new forest-related information whenever possible and on the information previously submitted to the FRA 2005 reporting process.


Now we are aiming for the next important step of the FRA 2010 Country Reporting Process, which is the validation of final Country Reports. The validation will take place during the month of October. An official letter will be sent to the Head of Forestry in each country together with the country report requesting a validation. If no changes or modification are submitted before a given deadline, the reports will be considered validated and the information contained will be used for the data analysis.

2. The Remote Sensing Survey

A new internet based portal for downloading data and uploading results has been released for testing in the FRA 2010 Remote Sensing Survey. Public users can find out about the study and view and download the Landsat data. Authorised national expert users can login and download draft labelled polygons for checking and then upload the validated data and auxiallary information. The portal will be tested in the Pilot Study and ready for use by other countries in 2010.




- FRA Partners at the Joint Research Centre (JRC) of the European Commission have been very busy preparing the draft land-cover results for samples in the humid tropical countries. Substantial work has been done by staff in many countries to check and validate thousands of images so far and we value their input and experience.
- The first regional training and validation workshops are being organised jointly by JRC and FAO and will be held in Central and Eastern Africa in early October. Participants are coming from 8 countries for the workshop in Kinshasa DRC, and 9 countries in Nairobi, Kenya. A workshop will also be held in Brazil in November. Other countries will be involved in training later in 2009 and in 2010.
- A letter will be sent to National Correspondents (of countries with sample plots) asking them to help identify a suitable focal point for the FRA 2010 remote sensing survey.

Interesting images:

This image comes from a FRA sample tile in Spain and shows agricultural land in the southern half of the image and a mixture of natural and planted forests in the north. The high resolution Google Earth image on the right shows a detailed excerpt enabling the planted forest lines to be easily seen which can help with validation. 3. Special Studies

Forests, Poverty and Livelihoods

A FRA 2010 special study on forests and poverty aims to explore the possibility of showing the spatial links between forests and poverty. It will do this by overlaying geo-referenced forest information with information not only on village location but also on village wealth, as characterised in national censuses, illustrated in sample cases with quick local studies on livelihood cash and non-cash

income from all sources, with special reference to forests as well as off-farm resources in general.

The study aims to develop methods which can be applied in conjunction with global, regional and national maps of forest distribution to display the linkages between poverty and forests. The maps will be further informed by the sample of more intensive local scale cases. Better knowledge of these linkages can be used to develop programmes which target poverty more effectively, and which distinguish appropriate interventions for those living in remote forested regions and those living nearer to markets and roads. This understanding will also generate the chance of better conservation of biological diversity and better management of forest resources. A scoping of the study and identification of potential partners is currently being undertaken by Gill Shepherd.

Assessment and Monitoring of Forest Degradation

A Technical Meeting on "Assessment and Monitoring of Forest Degradation" took place at FAO Headquarters in Rome, Italy, from 8 to 10 September 2009.

The objectives of the meeting were to present and discuss an analysis of definitions of forest degradation, and a series of case studies on forest degradation and to recommend actions to improve measurement, assessment and reporting on forest degradation. The meeting provided an opportunity for participants to discuss technical aspects of methodologies for assessing and monitoring forest degradation.

The main conclusions were as follows:

- 1. Endorsement of the generic definition of "forest degradation" as a "reduction in the capacity of a forest to provide goods and services";
- 2. The many different aspects of forest degradation should be communicated better e.g. to the climate change negotiators;
- 3. Attention should be focused on harmonization of definitions and methods for monitoring five aspects of forest degradation: stocking level, biodiversity, forest health, level of use/production and forest soil
- 4. Methodologies do exist to monitor changes in carbon stocks and therefore to include forest degradation in terms of climate change into the proposed REDD mechanism.

There was also a call for the development of tools and guidelines for measuring different aspects of forest degradation. Some selected case studies and the outcome of this meeting will be also presented at the World Forestry Congress.

6. National Forest Monitoring Assessment (NFMA) at the WFC

The FAO NFMA programme is organising three events for the World Forestry Congress.

The first is one of the Technical sessions on "State of the forests and assessment techniques", focusing on field level/national forest inventories. The following four presentations are scheduled:

- Large area forest inventories as potential data sources for the international conventions issues and options by Prof. Christoph Kleinn et al
- 2. The Floristic and forest Inventory of Santa Catarina in Southern Brazil, by Alexander Christian Vibrans et al.
- 3. The National Forest Inventory Program of Korea: Findings and Lessons
- 4. Measuring and Monitoring Forest degradation Through National Forest Monitoring and Assessment by M. Saket et al.

The second is a side event on "National forest monitoring and assessment: an essential tool for national policies and international reporting". The following three presentations are scheduled:

- 1. FAO National Forest Monitoring Programme (NFMA) Progress and way forward
- 2. Practical NFMA experience from Nicaragua
- National Forest Inventory (NFI) System of Brazil Support to national policies for SFM and international reporting e.g. biodiversity, carbon, REDD, etc.

A round table will be held for brief presentation of four themes namely biodiversity, REDD, Socio-economic information in NFMA and challenges of NFI implementation in Brazil.

Finally there will be the **Inaugural meeting of the Advisory Panel** for FAO NFMA programme. The meeting will discuss the organization, mandate and functioning of the Advisory Panel as well as the strategy and priorities of the NFMA programme.

UNECE Timber Committee

The 67th session of the UNECE Timber Committee will take place from 12 to 16 October 2009, in Geneva.

The week begins on 12 October with a green building workshop on "Responding to Climate Change: Wood's place in a global approach to green building". On 13-14 October the Timber Committee sessions will start with the annual Market Discussions on "UNECE region forest products markets in a global economic crisis".

United Nations Climate Change Conference

COP15 is the fifteenth Conference of the Parties to the United Nations Framework Convention on Climate Change. Key issues to be discussed include a post Kyoto Protocol Agreement and a mechanism to reduce emission from deforestation and forest degradation in developing countreis (REDD). The conference will take place from 7 to 18 December 2009, in the Bella Center in Copenhagen, Denmark.

WFC XIII


The XIII World Forestry Congress will be held from 18 to 23 October 2009 in the city of Buenos Aires and its theme will be "Forests in development: a vital balance."
