

## Panel Discussion: Private Sector Perspectives on AMR Mitigation

14 March 2019; Bangkok, Thailand

### CONCEPT NOTE

#### Background and justification:

The UN Inter-Agency Coordination Group on antimicrobial resistance (IACG), whose mandate is to provide practical guidance for approaches needed to ensure sustained effective global action to address antimicrobial resistance (AMR), reiterates the urgent need to develop a shared global vision, narrative and targets to tackle antimicrobial resistance and mobilize all relevant stakeholders in support of country-level actions. While it is recognized that multisectoral efforts involving all stakeholders are essential to tackle challenges posed by AMR, engagement with the private sector has been limited.

Recognizing the crucial importance of this engagement to succeed in AMR mitigation, FAO Regional Office for Asia and the Pacific (FAO RAP), through the support from the USAID Project (*OSRO/RAS/502: Addressing Antimicrobial Usage in Asia's Livestock, Aquaculture and Crop Production Systems*), is looking at bridging this gap and preparing to find ways to understand what will be needed to effect action and catalyze change towards a unified and shared global vision on AMR in the region.

Preparing to start seeking collective inputs from critical stakeholders to help shape future conversations on AMR, FAO RAP is hosting a brief panel discussion entitled "*Private sector perspectives on AMR mitigation*" during the FAVA-VIV Asia Seminar 2019 on March 14, 2019 at VIV Asia 2019, BITEC, Bangna, Thailand. This panel discussion will seek to hear and understand the private sector insights on AMR, and how future engagements could best proceed. Inputs gathered from this session will help in the development of the Concept Note for the Regional Consultation and other future initiatives involving the private sector and civil societies in the region.

#### Objectives/Outcomes

This panel discussion aims to:

1. Obtain insights of the private sector on antimicrobial resistance mitigation in the region.
2. Gather suggestions from which the Concept Note for the regional private sector consultation may be built on.

#### Expected Outputs:

At the end of the consultation meeting, it is expected that:

1. A list of key points on the views of the private sector regarding AMR mitigation is initially drafted.
2. Ways to bring forward the conversation will be identified.
