



Foreword

The Banana Statistical Compendium is issued on an annual basis to Members and Observers of the Sub-Group on Bananas of the Intergovernmental Group on Bananas and Tropical Fruits, which is a subsidiary body of the Committee on Commodity Problems (CCP).

It is prepared by the Team on International Investment and Tropical Fruits, Trade and Market Division, FAO, Rome, and the tables contained bring together the information available to FAO, supplemented by data obtained from other sources in particular with regard to preliminary estimates.

The Team on International Investment and Tropical Fruits provides research and analyses on agricultural investments in developing countries, and economic data and analyses on tropical fruits. Regular publications include market reviews, outlook appraisals and projections for bananas and tropical fruits. The team also provides assistance to developing countries in designing and implementing national policies regarding responsible investment in agriculture.

Note on methodology

Data on trade volumes published in this statistical compendium were compiled from: the responses to the annual questionnaire of the FAO Intergovernmental Sub-Group on Bananas (2007-2016); data from the UN Comtrade database; and secondary data from desk research. Price data were collected from several official sources, as respectively stated in the footnotes. All datasets refer to global trade of fresh bananas, excluding plantains, as covered by HS code 080390 under the harmonized tariff nomenclature system of the World Customs Organization. All data are provisional.

Data on the European Union and the United States of America import volumes by origin are compiled from data provided by the European Commission and the US Department of Agriculture (USDA), respectively. Data are reported as collected and totals may differ from the

processed and validated data reported in the 'World import by country' tables. In the current edition of the statistical compendium, this results in a significant discrepancy between exports of bananas reported from the Dominican Republic in Table 1: 'World gross exports by country' and those reported in Table 6: 'Gross imports by countries of origin'.

Changes in Statistical Compendium 2018:

Table 1: Historical data on gross exports by country were revised back to 2012 to include exports of bananas from Mozambique, which have experienced substantial growth from 2014 onwards.
