Andrew Taber

Andrew Taber is a Senior Forestry Officer in the Food and Agriculture Organization of the United Nations. As Team Leader for Social Forestry, he oversees work in community forestry and tenure, producer organizations and small enterprise, gender, indigenous peoples, and links between forests and food security and nutrition. Previously, he headed an international NGO dedicated to sustainable mountain development and has held senior positions in international forestry research and wildlife conservation organizations. His expertise spans community-based wildlife management, landscape conservation, climate change adaptation, capacity building and administration. He is a scientific authority on Neotropical wildlife and ecosystems and has participated in international policy processes. He has trained and mentored practitioners and researchers and holds a doctorate from Oxford University as well as learned from holders of traditional knowledge.


Sandra Rodríguez-Piñeros

John Innes

John Innes is Dean of the Faculty of Forestry at the University of British Columbia. He is President of the Commonwealth Forestry Association (since 2010), Chair of the Standing Committee on Commonwealth Forestry and Chair of the Asia-Pacific Forestry Education Coordination Mechanism. He is actively involved with climate change research and in 2007 was part of the IPCC team that shared the Nobel Peace Prize with Al Gore. For his lifetime contributions, he received the International Forestry Achievement Award by the Canadian Institute of Forestry (2015) and was bestowed International Fellowship by the Royal Swedish Academy for Agriculture and Forestry (2018).

Felix Finkbeiner

At the age of 9, Felix Finkbeiner, developed the idea that children could promote climate justice by planting a million trees in every country. With the support of children from all over the world, Felix launched the youth initiative Plant-for-the-Planet in 2007. This gave rise to the Trillion Tree Campaign with the goal of planting 1 trillion trees until 2030. So far, more than 91,000 children and youth in 75 countries have been trained in Plant-for-the-Planet Academies. As Climate Justice Ambassadors, these children and youth give speeches to adults, motivating them to act. Felix is a Ph.D. candidate at ETH Zurich studying the potential of forest restoration in addressing the climate crisis.
