Regarding "Building effective value chains and aquaculture in the Caribbean with specific focus on empowering women and youth": the funders withdrew.

Regarding Improving resilience to climate change of the fisheries sector through improvements in data collection and statistics - Grenada, Dominica, SVG and T and T - Improve data collection and statistics to improve fisheries management, climate change resilience and value traceability (311) USD 120 000.

- REBYC II LAC (EP/GLOF/201/GEF): finance Suriname's participation to the regional training on statistics and post-disaster assessement held in TT in January support to the establishment of Calipseo in Suriname: CC4FISH built onto work financed by Rebyc in T and T (so CC4FISH and Rebyc financed improved data collection and statistics in TT).
- CLME+ (UNJP/RLA/217/OPS): support for the analysis of statistical data for stock assessments in Suriname and TT. Same as above.
- JPN 198 (GCP/INT/228/JPN): support to the establishment of Calipseo in the Fisheries Division in TT. Same as above.
- WECACF-FIRMS phase 3 (GCP/SLC/020/EC): financial support to run the WECAFC-FIRMS task force which enabled the identification and coordination of activities needed for fisheries data and statistics in the projects mentioned above, including CC4Fish.

Listed in Table d/: 4 projects in total (2 above) because (i) OneSkip still included but under IDB project, (ii) SVC4SIDS funder withdrew.

Regarding the India – \_UN Development Partnership Fund for building resilience after COVID-19 - Support fisheries value chains in Grenada (USD 113 400) which was listed in Table b: The India project was not funded by project after all. We prepared (together with the other UN agencies) the concept note and Grenada submitted it to India but at the end the donor country did not provide the funding.
