Narrow the scope and focus of the project and gradually scale up the project activities in similar strategic dimensions. In this regard, instead of merging different topics (e.g. the NFI, FMP, income generation, and pasture rehabilitation), it is highly recommended to keep focused on one specific strategic dimension (e.g. focusing on only the NFI and scaling it up to cover other regions of the country, or focusing only on FMP work and scaling it up). Moreover, the project design needs to address all three layers of capacity development along with a timeline approach (legal framework and policy, institutional and individual capacity layers) to secure project sustainability.
