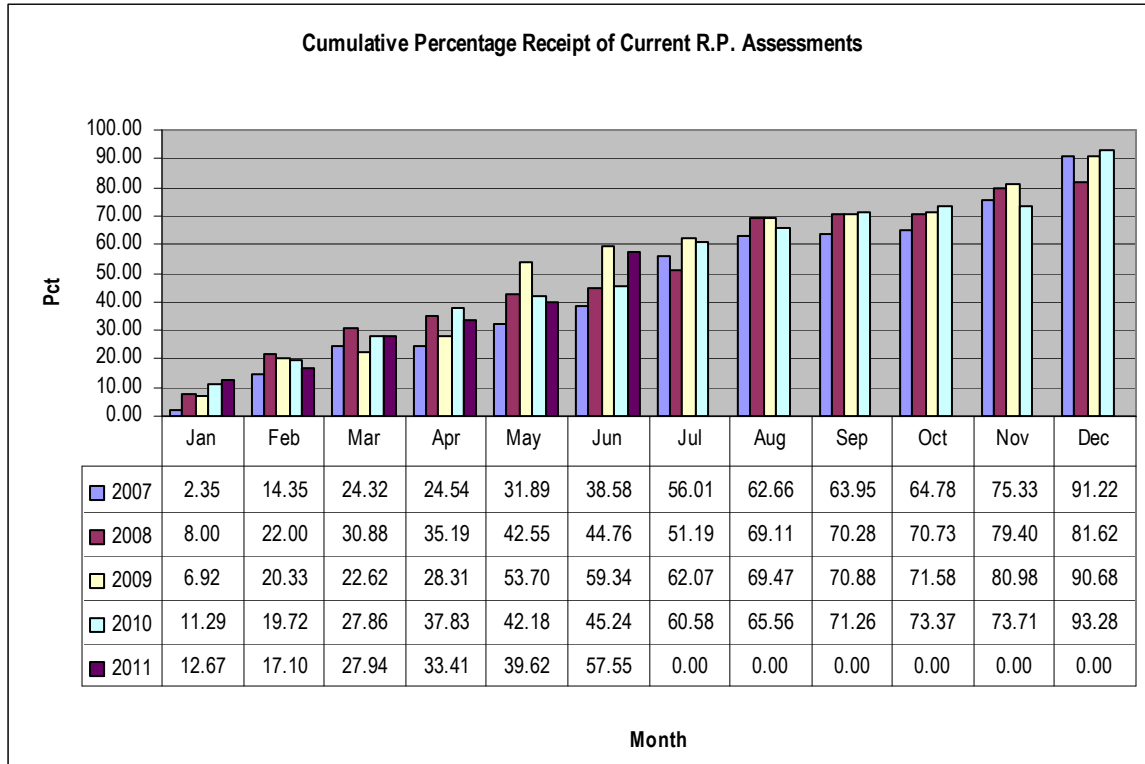

**ADDITIONAL INFORMATION REGARDING ARREARS DUE AT
25 June 2011**

- The total arrears at 25 June 2011 was USD 15,806,619.68 and EUR 2,492,147.80 (*Appendix B/Appendix C*) equivalent to 3.72% of current assessments.
- Four Member Nations had arrears in excess of USD 1 million (*Appendix C*).
- Arrears exceeding USD 1 million accounted for 68.69% of the total arrears due.
- Thirteen Member Nations had arrears in such amounts as to jeopardise their right to vote in accordance with Article III.4 of the Constitution (*Appendix G*).
- The total of 47 Member Nations in arrears at 25 June 2011 was lower than the figure of 54 as at 25 June 2010.
