II. CONVENTIONS AND AGREEMENTS CONCLUDED UNDER ARTICLE XIV OF THE FAO CONSTITUTION

Agreement for the Establishment of the
Indo-Pacific Fishery Commission

On 22 July 1993, the People's Republic of China deposited an instrument of acceptance to the Agreement.

International Plant Protection Convention

On 17 August 1993, the Government of the Federal Republic of Nigeria deposited an instrument of adherence to the Convention.

International Convention for the Conservation
of Atlantic Tunas

Paris Protocol of 10 July 1984

On 6 September 1993, the Government of the Republic of Guinea deposited an instrument of acceptance to the Paris Protocol amending the Convention.

Madrid Protocol of 5 June 1992

On 22 September 1993, the Permanent Representative of Canada to FAO, signed, on behalf of his Government, the Protocol amending paragraph 2 of Article X of the Convention and, at the same time, deposited an instrument of ratification thereto.

On 30 September 1993, the Government of the Republic of South Africa deposited an instrument of acceptance to the Protocol amending paragraph 2 of Article X of the Convention.

**Regional Convention on Fisheries Cooperation
among African States bordering the Atlantic Ocean**

On 5 August 1993 the Government of the Republic of Guinea deposited an instrument of ratification to the Convention.

**IV. CONVENTION ON THE PRIVILEGES AND IMMUNITIES OF THE
SPECIALIZED AGENCIES**

An instrument of accession by the Government of the Republic of Cameroon to the 1947 Convention on the Privileges and Immunities of the Specialized Agencies was received by the Secretary-General of the United Nations on 30 April 1992.

An instrument of succession by the Government of the Czech Republic to the Convention was received by the Secretary-General of the United Nations on 22 February 1993.

An instrument of succession by the Government of the Republic of Bosnia and Herzegovina to the Convention was received by the Secretary-General on 1 September 1993.
