LOCUST SITUATION IN PAKISTAN (16th October, 2007 to 15th November, 2007)

Pakistan remained free from gregarious locust activity during the period under report. However, scattered mature / immature solitary adults ranging from 05-50/ ha. were observed in 33 localities of Bahawalpur and Rahimyar Khan areas of Cholistan. A maximum population of 50 adults/hectare was observed at Zarrar Post (275307N-712455E) in Bahawalpur on 11-11-2007 during the reporting period.

The mixed population of immature fresh fliers, fledglings and hoppers of 5th instar in an area of 700 hectares was reported at Bada (282331N-653072E), Tagap (282329N-652861E), Nali (282219N-652612E) and Ormaga (281871N-643256E) in Kharan desert area which were successfully controlled by consuming 680 litres of pesticides from 26-10-2007 to 31-10-2007.

Two small swarms of fresh fliers in an area of 250 hectares was also controlled at Dallo (282179N-643517E) and Isapabad (283157N-6252517E) by consuming 220 litres of liquid pesticides on 02nd and 06th November, 2007 respectively in the desert of Kharan in winter / spring breeding areas.

WEATHER

Hot and dry weather prevailed over the entire locust breeding zones during the reporting period.

LOCUST SITUATION IN INDIA (01st October, 2007 to 31st October, 2007)

Scheduled short, distant and border desert locust surveys in the Scheduled Desert Area of India and adjacent Indo-Pak border were conducted by the officers and staff of Locust Warning Organization which revealed that India continued to remain free from any gregarious desert locust activity. Soil moisture was not suitable for locust breeding along Indo-Pak border.

WEATHER

Rainfall:

No rainfall has been reported from nay part of the scheduled desert area of India.

Wind Direction:

Wind direction at 300 m remained variable during the month.

FORECAST:

Desert locust activity is expected to decline in coming months in both the countries because of prevailing low temperature in the desert area and seasonal movement of desert locust towards the winter / spring breeding areas. Hence, strict vigilance on locust development in the Scheduled Desert Area of India and Pakistan be maintained.

MISCELLANEOUS

 Fortnightly desert locust situation bulletins were exchanged between the two delegates.

The 01st border meeting of the year 2008 would be held at Munabao / Khokhropar border point on 10th June, 2008 at 0830 hours (IST) / 0800 hours (PST).
