# SUBJECT: Request for comments on the draft Guidance for the Management of Biological Foodborne Outbreaks

## DEADLINE: 8 January 2022

## BACKGROUND

- The 51<sup>st</sup> Session of the Committee on Food Hygiene (CCFH51) advanced the Guidance for the Management of Biological Foodborne Outbreaks to Step 5.<sup>1</sup> The Guidance was adopted at Step 5 by CAC43 and advanced to Step 6<sup>2</sup>. Comments were requested at Step 6 through Circular Letter, <u>CL 2021/04/OCS-FH</u>.
- 2. Comments in response to the aforementioned CL are compiled in CX/FH 22/52/5.
- 3. In view of the postponement of CCFH52 from 2021 to 2022, and to benefit from the additional time to continue to progress this work, Denmark, Chile and the European Union analysed and attempted to address the comments received and have accordingly prepared a revised draft Guidance for consideration and comment. For further background information and the revised draft Guidance, see <u>CX/FH 22/52/5 Add.1</u>.

### **REQUEST FOR COMMENTS**

- Codex members and observers are invited to provide comments on the revised draft Guidance provided in Appendix I of <u>CX/FH 22/52/5 Add.1</u> and consider whether it is ready to be advanced to Step 8 for adoption by CAC45.
- When providing comments, consideration should be given to previous discussions and decisions by CCFH, comments previously provided and compiled in <u>CX/FH 22/52/5</u> and the analysis and consideration of comments provided in <u>CX/FH 22/52/5 Add.1</u>.
