DRAFT PROVISIONAL AGENDAS FOR CCEXEC75 AND CAC41

- 1. In accordance with Rule VII.1 of the Rules of Procedure of the Codex Alimentarius Commission, the Provisional Agenda for each Commission session is prepared by the Directors-General of FAO and WHO in consultation with the Chairperson of the Commission or with the Executive Committee. It has been the usual practice to consider the draft Provisional Agenda in the Executive Committee.
- 2. The final Provisional Agenda will be prepared by the Directors-General on the basis of the recommendations of the Executive Committee and in consultation with the Chairperson.

Recommendation

- CCEXEC is invited to consider:
 - (i) the draft provisional agenda of CAC41 (Annex I) and provide inputs for consideration by Directors-General of FAO and WHO when preparing the final provisional agenda in consultation with the Chairperson; and in particular to consider the suitability to:
 - a. have a five days session; and
 - b. replace the items (15.1, 15.2 and 15.3) on FAO/WHO capacity development activities, provision of scientific advice and CTF2 with side events and report the main findings to the Commission.
 - (ii) the draft provisional agenda of CCEXEC75 (Annex II) and provide inputs for consideration when preparing the final provisional agenda; and in particular the suitability to:
 - consider only once per year the item on the Applications from International Non-Governmental Organizations for Observer Status in Codex in the agenda of CCEXEC; and
 - b. hold CCEXEC75 session from Tuesday to Friday.
