RELATIONS BETWEEN THE CODEX ALIMENTARIUS COMMISSION AND OTHER INTERNATIONAL ORGANIZATIONS

APPLICATIONS FOR OBSERVER STATUS IN CODEX

1. The 28th Session of the Codex Alimentarius Commission (July 2005) adopted amendments to the Rule concerning Observers (current Rule IX.4, 5 and 6) of the Rules of Procedure of the Commission as well as the revised Principles concerning the Participation of International Non-Governmental Organizations in the Work of the Codex Alimentarius Commission. Under these Rules and Principles in force, the advice of the Executive Committee is to be sought by the Directors-General of FAO and WHO when handling the relations between the Commission and international non-governmental organizations.

2. The Executive Committee is hereby **invited**, in accordance with Rule IX.6 of the Rules of Procedure and the above-mentioned Principles, to provide advice regarding the applications for observer status from two international non-governmental organizations neither having status with FAO nor official relations with WHO, as included in <u>Annexes</u>. Other relevant information received from the applicant organization will be made available to the Executive Committee in a separate document.

3. The Directors-General of FAO and WHO will decide whether the applicant organizations are to be granted observer status, taking into account all relevant information received from the applicant and the advice of the Executive Committee.

The objective of BEUC is to act on behalf of its 37 national member organisations to seek to influence in the consumer interest the evolution of EU policy. BEUC was founded in 1962.

Membership of BEUC is open to independent national consumer organisation from any European country. Full or voting membership is confined to organisations from EU/EEA member states.

The primary governing body of BEUC is the General Assembly of all members, which normally meets twice a year. Between General Assemblies the organisation is supervised by an Executive Committee and managed by the director and secretariat. The secretariat currently consists of 24 employees.

Over 50% of BEUC income comes in the form of membership contributions from member organisations — based on 0.45% of their annual turnover. We also receive an annual subsidy from the European Commission in the range of 43-47% of our total budget. Our ordinary budget (excluding once-off projects) is about 2,3 million euros

No special relationship; occasional contact.

We work closely with our sister organisation Consumers International on food and other issues, and will continue to do so.

We work with our US partners in the Transatlantic Consumer Dialogue.

As a European Consumer Organisation we are entitled to one seat on the European Commission's European Consumers Consultative Group and we have numerous contacts on a daily basis with all the key institutions of the EU.

(i) Expected contribution to the Joint FAO/WHO Food Standards Programme

Our contribution would be to reflect the consensus views of our members on consumer issues in different Codex committees. Given the adhesion of the European Commission and the fact that many European industry associations already have observer status we wish to add the voice of European consumer organisations to the work of CODEX.

(j) Past activities on behalf of, or in relation to, the Codex Alimentarius Commission and the Joint FAO/WHO Food Standards Programme (indicate any relationship by national affiliates with the Regional Coordinating Committees and/or the National Codex Contact Points or Committees for at least the last three years preceding the application)

BEUC has contributed so far via CI on the following issues:

- Pesticides Codex Committee on Pesticide Residues;
- Hygiene Codex Committee on Food Hygiene;
- Claims/labelling Codex Committee on Food Labelling and Codex Committee on Nutrition and Foods for Special Dietary Uses;
- Regular consideration or contribution to Codex Alimentarius Task Force on Foods Derived from Biotechnology.

The Codex Committee on General Principles and the Codex Committee on Food Additives and Contaminates are particularly important for us.

There have been a number of previous contacts with the regional European committee. In September this year, BEUC food advisor Beate Kettlitz was the only representative in the CI delegation.

While reflecting the concerns of our members in Europe, BEUC will continue to work closely with Consumers International and continue to share the task of articulating the consumer voice in our work with CODEX.

Annex to BEUC Submission for Observer Status with CODEX

This annex is added to clarify the working relation between BEUC and Consumers International (CI) in relation to Codex.

1 BEUC does not seek separate or parallel representation specifically in relation to the CODEX Commission or any subsidiary body as such.

2 Consumers international, with the full support of BEUC, will have the lead role in relation to consumer representation at CODEX.

- 3 There are three sets of circumstances in which BEUC may wish to have separate or parallel representation to the extent that this is permitted under the relevant CODEX rules:
 - When BEUC is acting with or on behalf of CI, and at the request of CI.
 - At a meeting in which BEUC has a specific interest and at which CI is not represented.
 - At a meeting at which CI is represented, but on an agenda item of specific interest to BEUC but not to CI. There may, for example, be issues that have a specific regional (European), but not global, impact. In relation to such items, only BEUC would intervene. In practice there may be few such occasions but the possibility cannot be excluded.

Should our application be accepted we would like to avail of the above three forms of separate or parallel representation, but subject of course to any limitations that may be imposed by CODEX rules.

The Natural Solutions Foundation is not a membership organization, but does accept individuals and organizations as affiliates, none of which already enjoy observer status. The affiliate list of the organization is private and confidential.

The Trustees and Advisor: Major A. N. General Stubblebine (US Army, Ret), Rima Laibow, MD, John L. Wilson, MD, Sgt. Major Robert Mawson (UK Army Ret.), Ralph Fucetola JD, Lawrence Plumee, MD, James Coy, MD, James Willoughby, MD, Steven M. Singer, Thomas Lawler, Michael D. Ostrolenk, Gianfranco Lombardi (Italy), Zied Ben Salah (Tunesia), Susan Benoit, Camilla Rees and James Gormley.

The core activist group of the Foundation consists of about a dozen individuals, including several attorneys at law, doctors, nutritionists and a retired major general. These individuals live mostly in the United States but also include several Europeans and Africans. The wider support base of the organization includes 10,000+ individuals and organizations who have opted to be included in the organization's email contact list. This support group includes mostly United States persons, but also includes individuals from the European Union, several African countries, including the Republic of South Africa and Southeast Asia.

(e) Structure (assembly or conference; council or other form of governing body; type of general secretariat; commissions on special topics, if any; etc.)

Major General Albert N. Stubblebine III (US Army, Ret) is the President of the Foundation. Rima Laibow, MD is the Medical Director.

The President and other operating Officers of the Natural Solutions Foundation receive input from a Board of Advisors (the key supporters of the organization) and act as needed, as Trustees of the organization through annual and periodic meetings, including telephone conferences.

Funding is entirely through direct funding resulting from private donations. No grants have been applied for or received.

(g) Meetings (indicate frequency and average attendance; send report of previous meeting, including any resolutions passed) that are concerned with matters covering all or part of the Commission's field of activity

The Natural Solutions Foundation operates through regular (generally weekly) telephone conference calls among its key supporters and has an annual affiliate meeting scheduled for mid-Summer. Formal Trustee meetings are held annually at that time.

(*h*) Relations with other international organizations:

- UN and its organs (indicate consultative status or other relationship, if any)

The Natural Solutions Foundation has not yet consummated any relationships with any UN body or organ.

- Other international organizations (document substantive activities)

The Natural Solutions Foundation has not yet completed consummation of relationships with international organizations, but has attended a number of international meetings, including a meeting of Developing Countries in Africa this past February, as an Observer.

The Natural Solutions Foundation was invited to attend the meeting of the Ministers of Health of 42 African countries and their top aides. NSF was admitted to the meeting as an Observer that did not yet have formal credentials with the Regional African Organization (although NSF is working on becoming credentialed participants). When the discussion turned to what the NSF Medical Director, Rima Laibow, MD, felt to be inaccurate Avian Flu information, its prevention and treatment, the just elected President of the organization asked Dr. Laibow to address the meeting, which she did.

The Foundation has also made presentations to the US Food and Drug Administration and has submitted a Citizens' Petition to the FDA regarding the application of US law to the Codex process.

(i) Expected contribution to the Joint FAO/WHO Food Standards Programme

The Natural Solutions Foundation anticipates making salient contributions to the Joint FAO/WHO Food Standards Programme by submitting commentary and suggestions to this body on issues which touch on consumer well being, crafted by affiliated attorneys at law and physicians.
