COMMENTS OF SUDAN

- SUDAN appreciates the opportunity to submit information as requested by the Codex Secretariat on visa
 issuance problems when encounter to attend Codex meetings. We note that this subject was proposed
 by Cameroon and flagged under "Other Business (Agenda Item 13)" during CAC38, but it was not
 discussed due to time constraints. The Commission noted this agenda item and Sudan welcome the fact
 that this will be discussed at the CAC39.
- Embassies which are not present or acting in Sudan, requires our delegates to communicate with or physically present themselves at the consular offices of the host government in Egypt. This process is costly, time-consuming and may present logistical challenges
- Considerable delays in the issuance of visas from some host countries, even when sometimes visa arrangement starts in suitable time.
- Some host countries require additional information from there related ministries, For example A letter of clearance from the Ministry of home Affairs, Political Clearance for organizing the Second Session of the Codex Committee on Spices and Culinary Herbs (CCSCH) from September 14-18, 2015 delayed our delegates and cancelled their participation to the meeting due to the un received letter from the host country.
