## Proposal for a standard for Halal food<sup>2</sup>

- CCNEA18 agreed to continue to work by electronic means to revise the project document for consideration by CCFL43. The revised project document will address gaps in relation to the labelling of halal food so that CCFL43 can make a decision on the possible revision of the Guidelines for the Use of the Term Halal (CAC/GL 24-1997).
- CCNEA18 recommended that work on halal food should be limited to the revision of the Guidelines for the Use of the Term Halal in CCFL for the time being with full participation from Member countries taking into account the standards and related texts developed at the level of Islamic countries e.g. OIC/SMIIC as reference documents.
