Comments on Agenda item 6, 7e and 10, submitted by Morocco

CL 2018/11-PR : REQUEST FOR COMMENTS ON THE RECOMMENDATIONS OF THE 2017 JOINT FAO/WHO MEETING ON PESTICIDE RESIDUES (JMPR)

Morocco has no objection for recommended MRLs. However, this opinion could be changed in the case where Morocco has a consumption data on the highest large portion.

In the other hand, Natamycin is not registrated as a plant protection product in Morocco. And this decision is taken for all pesticides with the antibiotics as an active ingredient.

Groupe 022 Tree nuts:

Pistachio nut is harvested when the fruit is ripe and the hull is opened. Hence, this commodity is likely to receive more residues than other closed-shelled fruits, especially in the case of pesticide are applied around the end of the Pistachio crop cycle.

Since among the criteria for selection of representative products is to choose a major crop that would most likely contain the most residues, and as the product is placed at Group 022 Tree nuts with two representatives commodities of the group (except Cocco nuts).

Morocco recommends revisiting the opportunity to extrapolate pesticide MRLs from closed nuts on pistachios. Hence, we propose to consider the pistachio among the representative commodities of the group.

Subgroup 023B Sunflower seeds

We suggset to add soyben in the Subgroup 023B Sunflower seeds.

- a) Add in Code No. HH 0738 Mint: Mentha viridis L. as a synonym of Mentha spicata.
- b) Add in Code No. HH 0750 Thyme: Thymus satureioides COSSON.
- c) Add in Code No. HH 0752 Wintergreen, leaves: Artemisia herba-alba Asso (white wormwood).
- d) Add a New Code No. for Verbena, leaves with commodities :
 - Aloysia citriodora Palau syn.: Aloysia triphylla (L'Hér.) Britton, Lippia citriodora Kunth, Lippia triphylla (L'Hér.) Kuntze, Verbena triphylla L'Hér.
 - Verbena officinalis L.
- e) Add a New Code No. for camomille with commodities :
 - o Chamaemelum nobile L. Syn. Anthemis nobilis L.
 - Matricaria recutita L. Syn. Matricaria chamomilla L.

CX/PR 18/50/14: INFORMATION ON NATIONAL REGISTRATIONS OF PESTICIDES

Morocco's answers:

a) It is suggested that no more than 20 - 30 active substances should be added to the National Registration Database each year. Do Member countries consider this to be an acceptable and manageable number?

b) From time to time the content of the National Registration Database needs an update concerning registered uses. Is a 5 year cycle acceptable?

c) The Chair and co-chair of the EWG on Priorities propose to publish the complete National Registration Database in a non-changeable format.
