NOTES ON THE PROVISIONAL AGENDA

Revision of the Classification of Food and Feed

Agenda Item 7(g): Common definition for edible animal tissues to facilitate the establishment of MRLs for pesticides and veterinary drugs for compounds with dual uses (= pesticides and veterinary drugs)

CCRVD24 (2018) agreed that the EWG on the definition of animal tissues to facilitate the establishment of MRLs for compounds with dual uses (i.e. pesticides and veterinary drugs) will coordinate with the EWG on the revision of the Classification of Food and Feed established by CCPR50 (2018) to elaborate a definition for edible animal tissues of relevance for the purpose of harmonization and the elaboration of MRLs.

CCEXEC75 (2018) made a joint recommendation to the CCPR/EWG on the revision of the Classification and the CCRVD/EWG on the definition of edible animal tissues that both EWGs work closely on the definition of edible animal tissues to develop a harmonized definition that would facilitate the establishment of MRLs for pesticides and veterinary drugs.

This recommendation follows the recommendation of CCEXEC73 (2017) on closer cooperation between CCPR and CCRVD on issues of mutual interest for compounds used as pesticides and veterinary drugs and exploration of innovative ways to foster such collaboration as well as the discussions and decisions of CCPR50 and CCRVD24 in this regard.

Plant protection and veterinary services of Codex member countries are kindly invited to share this document and consider the issues raised in the paper (including conclusions and recommendations if any) and provide feedback to CCPR accordingly. Codex observer organizations having interest in compounds with dual uses are invited to do the same. Relevant work of JECFA and JMPR on harmonization of risk assessment procedures for the safety evaluation of pesticides and veterinary drugs as reported under Agenda Item 4(a) should also be taken into account when considering this paper.

The above will allow CCPR to provide suitable guidance on this matter so that work can further progress in both EWGs.

Establishment of Codex MRLs for pesticides

Agenda Items 12/13/14: Management of unsupported compounds, national registration of pesticides and priority lists of pesticides for evaluation by JMPR

These items are inter-related and deal with how the Committee can further improve the establishment of MRLs for pesticides for food and feed under the current procedures described in the *Risk Analysis Principles for the Establishment of Maximum Residue Limits for Pesticides by the Committee on Pesticide Residues*. Codex members and observers are kindly invited to consider the conclusions and recommendations in these papers in a holistic manner in order to provide useful guidance to CCPR when considering these agenda items.

Agenda Item 14: Establishment of Priority lists of pesticides for evaluation by JMPR

The elaboration of the Priority List corresponds to Step 1 of the Codex MRLs Elaboration Procedure. CCPR will consider a document prepared by the Chair of the EWG/Priorities (presented as a CRD) based on CX/PR 19/51/19 and comments submitted during the discussion on Agenda Item 6.

Other related items

Agenda Item 4a/9: The report on acute probabilistic exposure assessment for pesticides should be read in light of the review of the IESTI equations with regard to a review of the basis and the parameters of the IESTI equations and a benchmark of the outcomes of IESTI equations to a probabilistic distribution of actual exposures.
