

NOTES ON THE PROVISIONAL AGENDA

Item 1- Adoption of the Agenda (CX/AF 03/1):

Item 3 - Consideration of the Proposed Draft Code of Practice on Good Animal Feeding (ALINORM 03/38, Appendix II; CX/AF 03/4; CX/AF 03/5; CX/AF 03/5 - Add. 1):

Primary objective of this agenda item is to discuss Section 5, 6 and 7 of the Proposed Draft Code of Practice on Good Animal Feeding. Discussion on Section 1-4 will focus on unsolved matters from the previous meetings.

- Report of the Drafting Group (CX/AF 03/5):

At its 3rd Session the Task Force agreed that a Drafting Group, led by Canada, reorganise Section 5 and revise Sections 6 and 7 of the draft Code (ALINORM 03/38, Appendix II) taking into account the discussion at its 3rd Session and the written comments submitted, for distribution prior to its next session.
