ARRANGEMENTS FOR THE SESSION

GENERAL INFORMATION

1. The Twenty-ninth Session of the Codex Alimentarius Commission will be held at the International Conference Centre of Geneva (Salle I), 15 rue Varembé, Geneva, Switzerland, from Monday 3 July until Friday 7 July 2006. The meeting will commence at 10:00 hrs on Monday 3 July. Registration will commence at 8.30 hours at the Reception Desk in the main entrance hall, on the ground floor of the same building. The adoption of the report will take place on Friday 7 July in the afternoon.
2. The Session is open to Member Nations and Associate Members of FAO and WHO which are members of the Commission, and to observers. Member Nations and Associate Members of both Organizations which are not members of the Codex Alimentarius Commission may attend as observers. The Session is also open to the public subject to the availability of seats, and to the media.
3. Expenses incurred in connection with attendance at sessions of the Commission and its subsidiary bodies and travel of delegations of the Members of the Commission and of the observers shall be borne by the governments or organizations concerned. Participants are also reminded that they are responsible for making their own hotel arrangements.
4. Members of the Commission attending the Session shall have one representative, who may be accompanied by one or more alternates or advisers. No delegate may represent more than one Member Nation or Associate Member.
5. Persons intending to participate at the Session may wish to refer to the **Guide for Delegates** for detailed information about facilities and services available in the CICG.

For reasons of economy, this document is produced in a limited number of copies. Delegates and observers are kindly requested to bring it to the meetings and to refrain from asking for additional copies, unless strictly indispensable.

10. Because the Commission's Rules of Procedure governing the composition of the Executive Committee require that not more than one delegate from any one country shall be a member of the Executive Committee (Rule V.1), these elections will take place in the following sequence:

Order	Election	Eligibility
1.	Election of Chairperson	Delegates from all Member Nations.
2.	Election of Vice-Chairpersons	Delegates from all Member Nations except the nation of the Chairperson.
