### ARRANGEMENTS FOR THE SESSION

#### GENERAL INFORMATION

1. The Thirty-Second Session of the Codex Alimentarius Commission will be held in the Plenary Hall, Third Floor, Building A, at FAO Headquarters from Monday 29 June to Saturday 4 July 2009. The meeting will commence at 10:00 hrs on Monday 29 June and may continue until the afternoon of Saturday 4 July.
2. The Session is open to Member Nations and Associate Members of FAO and WHO which are members of the Commission, and to observers. Member Nations and Associate Members of both Organizations which are not members of the Codex Alimentarius Commission may attend as observers. The Session is also open to the public subject to the availability of seats, and to the media.
3. Expenses incurred in connection with attendance at sessions of the Commission and its subsidiary bodies and travel of delegations of the Members of the Commission and of the observers shall be borne by the governments or organizations concerned. Participants are also reminded that they are responsible for making their own hotel arrangements.
4. Members of the Commission attending the Session shall have one representative, who may be accompanied by one or more alternates or advisers. No delegate may represent more than one Member Nation or Associate Member.
5. Registration facilities will be available from 08.00 hours in the Turkish Registration Room on the Ground Floor of the same building. More detailed information about facilities and services in the FAO Headquarters Complex will be provided upon registration.

#### LANGUAGES

6. The Session will be conducted in Arabic, Chinese, English, French and Spanish. Simultaneous interpretation facilities will be provided in these languages.

Order	Election/Appointment	Eligibility
1.	Appointment of Regional Coordinators	Based on the nominations made by FAO/WHO Coordinating Committees
2.	Election of Chairperson	Delegates from all Member Nations.
3.	Election of Vice-Chairpersons	Delegates from all Member Nations except the nation of the Chairperson.
4.	Election of Members of the Executive Committee elected on a geographic basis	Member Nations (on a regional basis) except the Coordinators and the nations of the Chairperson and Vice-Chairpersons.
