Introduction

- 1. At the 16th Session of the FAO/WHO Regional Coordinating Committee for Asia, the Coordinating Committee recalled that the 24th Session of the CCGP had agreed to invite all coordinating committees to discuss matters on the Terms of Reference for coordinating committees, in particular the inclusion of a sentence regarding promotion of adoption of regional positions on strategic subjects.
- 2. The Coordinating Committee was of the view that the Terms of Reference were sufficiently broad to allow the development of regional positions and that the problem of developing regional positions could be more effectively addressed by implementing specific activities than by amending the Terms of Reference. Therefore, it agreed that the current Terms of Reference were adequate.
- 3. In order to facilitate the development of regional positions, the Coordinating Committee agreed to add to its agenda, as a standing agenda item, the discussion of "Issues relevant to the region" and to request the Coordinator for the region to prepare a paper on this subject for consideration at its next session. It also noted that Objectives 3 of the draft Regional Strategic Plan for the CCASIA (*see* Agenda Item 6) included aspects related to the discussion of issues of interest to the region and to holding informal meetings of members of the region prior to Codex meetings (ALINORM 09/32/15 para 16-18).
- 4. It is also noted that at the 25th Session of the Codex Committee on General Principles, the Committee discussed terms of reference of FAO/WHO Coordinating Committees and concluded the discussion by confirming that the full freedom was given under the current Terms of Reference of FAO/WHO Coordinating Committees to issue regional opinions on all themes under discussion in Codex of strategic importance to the region concerned and to promote the adoption of regional positions on strategic subjects, and therefore there was no need to modify the Terms of Reference (ALINORM 09/32/33 para 103).
- 5. According to Action 3.1 of the Strategic Plan for the Coordinating Committee for Asia (CCASIA) 2009-2014, Coordinator is the responsible party to organize informal meetings of CCASIA prior to Codex meetings to develop common position, where possible, on issues of interest as well as to update on national and regional activities. Under Action 3.2, Coordinator and Member countries is the responsible party to discuss Codex issues of interest to the region including those issues arising from Commission and other Codex subsidiary bodies during CCASIA sessions.
- 6. Issues relevant to the region were identified for each Codex session during 2009-2010, in which Asian member countries concerned. Indonesia, in the capacity as Regional Coordinator for Asia, usually organized an Asian informal meeting prior to the Codex session in order to discuss all the issues of interests to Asia.
- 7. The Committee is invited to review all the issues identified (under column on "Issues relevant to the region" and "Notes") as included in Annex, with a view to providing views and recommendations, where appropriate.
