CRITICAL REVIEW FOR THE ELABORATION OF CODEX STANDARDS AND RELATED TEXTS
MONITORING OF STANDARDS DEVELOPMENT

BACKGROUND

1. In the framework of the Critical Review, the present document considers all items of work which are in the process of elaboration in Codex Committees. Draft Standards and Related Texts submitted to the Commission for Adoption are presented under Agenda Item 2 (a). New work items are presented under Agenda Item 2 (c).
2. The CCEXEC63 (2009) agreed that a list of discussion papers should be included in the document on monitoring for information purposes only, in order to present a complete view of the workload of each Committee, but would not be discussed as such. A list of discussion papers related to potential new work was therefore included, when applicable.
3. When recommendations have been made by previous sessions of the Executive Committee for specific items of work, they are also mentioned in the notes.
4. In accordance with Rule V.2 of the Rules of Procedure and with Paragraphs 5-8 in Part 2 "Critical Review" of the Procedures for the Elaboration of Codex Standards and Related Texts, the Executive Committee is invited to review the status of development of draft standards against the timeframe agreed by the Commission. In particular, the Executive Committee may propose an extension of the time frame; cancellation of work; or propose that the work be undertaken by a Committee other than the one to which it was originally entrusted.
5. To facilitate the conduct of monitoring progress of standards development, the CCEXEC58 (2006) agreed on the following criteria to be applied:
 - When progress on a standard is delayed due to the need for scientific advice, the Executive Committee could encourage FAO and WHO to schedule an expert consultation to provide such advice in a timely manner, and recommend suspension of work until such time as scientific advice became available;
 - When scientific advice has been provided and a standard has been under consideration for more than five years, the Executive Committee should urge the Committee concerned to take action within a specified timeframe;
 - When an item has been considered for several sessions without any progress and there is no prospect of reaching consensus, the Executive Committee could propose suspension of work at a particular Step in the Elaboration Procedure for a specified period of time or discontinuation of work, or corrective action to be taken to achieve progress, fully taking into consideration the information provided by the subsidiary body concerned.¹
6. This document only contains work carried out by Committees that have met since the CAC37 (2014).

CONCLUSION AND RECOMMENDATIONS

7. Overall the work of the Committees is progressing according to their respective schedules. However, work on 5 out of 19 standards has gone beyond the original schedule. Among the reasons for delays in completing work are: the interval between committee meetings; the complexity of the topics under discussion; the need for additional scientific advice, and inadequate timeframe/schedule for the nature of the task. Approaches in order to respect the planned timeframe include: through the increased use of PWGs prior to Committee sessions; by holding longer meetings and by reducing intervals between meetings. Workload has also been reduced through the discontinuation of certain work items.

8. Workload varies between Committees: some with a more extensive agenda than others; in this regard, CCFH has adopted a Forward Workplan which helps the Committee to ensure a continuous flow for a sustainable and more manageable agenda.

9. Therefore, it is proposed that the **CCEXEC recommends:**

- **CCPFV:** to give priority to the completion of the work on: (i) Proposed draft Annex on Canned Pineapples and (ii) Proposed draft Annexes on Quick Frozen Vegetables (including methods of analysis for quick frozen vegetables) in order to complete the review of the remaining standards for processed fruits and vegetables.
- **CCFL:** to give priority to the completion of the work on the Revision of the *Guidelines for the Production, Processing, Labelling and Marketing of Organically Produced Foods: Organic Aquaculture*.
- **CCCF:** to revise the schedule for completion of work on the Proposed draft maximum levels for lead in the *General Standard for Contaminants and Toxins in Food and Feed* (GSCTFF) and encourage countries to timely submit data to GEM Food.
- **CCPR:** to revise the schedule for the completion of work on the revision of the *Classification of Food and Feed* taking into account the remaining/new commodity groups.
- **All Committees:** to consider the need to develop an approach for the management of their work similar to that used by CCFH (while recognising the difference in the topics dealt, working procedures, etc. among various committees).
- **CAC38:** to approve discontinuation of work on (i) Proposed draft Regional Standard for Ayran; and (ii) Annex on statistical and mathematical considerations to the *Principles and Guidelines for the Establishment and Application of Microbiological Criteria Related to Foods* (CAC/GL 21-1997), as proposed by CCEURO and CCFH respectively.

At its 21 st session in October 2014 the Committee considered a discussion paper on consideration of emerging issues and future directions for the work of the Committee. The paper was a result of discussions held in the margins of CCFICS 20 as part of the 50 th anniversary celebrations for Codex, the discussions recognised the need for the committee to keep a standing item on its agenda that would facilitate discussion on its future strategy and work plan. The committee noted among other things that the committee would develop discussion papers on system comparability/equivalence and on electronic certificates in international food trade. The papers are being prepared through informal exchanges among members of the committee with the work being led by New Zealand and the Netherlands respectively. The discussion papers will facilitate further consideration of the priority and need to undertake work in these two areas at the next session of CCFICS in February 2016.

<p><u>Comments by the Chairperson/host country:</u></p> <p>Revision of the <i>Guidelines for the Production, Processing, Labelling and Marketing of Organically Produced Foods: Organic Aquaculture</i> : Due to time constraints resulting from extensive discussion and changes made to the proposed draft text, the Committee agreed to return the text to Step 3 for circulation for comments, and in preparation for the 43rd Session, that a physical working (PWG) would be convened with the goal of seeking to resolve differences and prepare proposals for consideration at the next session. The European Union agreed to lead the PWG. It is expected that this work may progress to Step 5 following the 43rd Session.</p> <p>Revision of the <i>General Standard for the Labelling of Prepackaged Foods: Date marking</i>: Due to the extensive changes made and some unresolved issues which need further discussion, the Committee agreed to return the proposed draft revision to Step 3 for further comments and consideration at the 43rd Session. <p><u>Comments by the Chairperson/host country:</u></p> <p>Standard for Laver Products: The proposed draft standard is redrafting by the EWG with possible PWG immediately prior to the next CCASIA. Further works needed to get to final agreement on product description, types and styles and on product compositions/quality factors and food additives in order to advance to next Step. The 19th CCASIA also agreed that the GSCTFF should be at least referred in the Standard and that, based on the results of preliminary exposure assessment, specific ML/GLs or other risk management measures of arsenic, cadmium or lead for laver products would not be necessary. Members were requested to submit occurrence and consumption data to GEMS/Food for more robust exposure assessment of arsenic, cadmium and lead in laver products. Members interested in the development of MLs for heavy metals in laver products are requested to prepare a discussion paper for consideration by the Committee on Contaminants in Foods (CCCF).</p> <p>Code of Hygienic Practice for Street-Vended Foods: Due to the length of the document and the limited time available, CCASIA only had a general discussion on scope, objectives and structure of the document. The proposed draft Code is redrafting by the EWG with possible PWG immediately prior to the next CCASIA. The proposed draft Code will be considered in details by the 20th CCASIA in order to advance it to next Step.</p> <p>Draft Strategic Plan for CCASIA 2015-2020: The 19th CCASIA was of the opinion that regional Strategic Plans might not be necessary as RCCs have a role to provide feedback and support to the global Codex Strategic Plan. It noted that specific activities of the draft regional Strategic Plan not addressed in the global Strategic Plan could be documented as a list of priority activities or Action Plan without the burden of developing, implementing and monitoring a regional Strategic Plan.</p>

Much collaborative discussions have been conducted regarding the work on <i>Salmonella</i> in beef and pork. The workgroup meeting in May, hosted by the EU, together with the expert consultation that will be held ahead of the next meeting, should produce a very mature document for the full committee to discuss at its next session in November. We expect this work to progress expeditiously. All other work is progressing as scheduled and the proposals for new work keep coming in.

<p><u>Comments by the Chairperson/host country:</u></p> <p>We have broad support for the items noted above. The discussion paper on the unintended presence of residues resulting from carry-over is important to ensure that we bound the scope of when we would consider drug residues in feed and ensure that we do not drift into the purview of the contaminants committee. The discussion paper on the establishment of a rating system is an opportunity for CCRVDF to consider and harvest best practices from other committees who have already implemented a rating system. Lastly, the Global survey is important work for CCRVDF to ensure that we are establishing MRLs, particularly for developing countries where the need is great, drawing attention to prioritized needs to secure dossiers to submit to JEFCA. All three actions are proactive work on the part of the CCRVDF to enhance its performance in meeting its terms of reference.</p>
