The Director-General of the Food and Agriculture Organization of the United Nations and the Director-General of the World Health Organization have the honour to extend an invitation to attend the above Session which will be held at the Discovery Kartika Plaza Hotel, Kuta, Bali, Indonesia, at the kind invitation of the Government of Indonesia. The Session will begin at 10 hours on Monday, 24 November 2014. Registration facilities will be open at 07.30 hours.

The Session is being convened under the authority of the Codex Alimentarius Commission, and is open to Member Nations and Associate Members of both Organizations, and to observers. Member Nations and Associate Members of both Organizations which are not Members of the Codex Alimentarius Commission may attend as observers. Expenses incurred in connection with attendance at sessions of the Commission and its subsidiary bodies and travel of delegations of the Members of the Commission and of the observers shall be borne by the governments or organizations concerned.

The Session will be conducted in English, French, German and Spanish. Arrangements for simultaneous interpretation will be the responsibility of the Host Government.
