## **BACKGROUND**

1. The 16<sup>th</sup> Session of the Codex Committee on Fresh Fruits and Vegetables (May 2011) agreed to advance the proposed draft Codex Standard for Pomegranate to Step 5 for adoption by the 34<sup>th</sup> Session of the Codex Alimentarius Commission (July 2011)<sup>2</sup>. The Commission adopted the Standard as proposed by the Committee and advanced it to Step 5 for comments and consideration by the 17<sup>th</sup> Session of the CCFFV<sup>3</sup>.
