#### ITEM 3: AMENDMENTS TO THE PROCEDURAL MANUAL

Indonesia supports the approval of the proposed amendments to the Codex Procedural Manual (Section 6, Section 2 and Editorial changes to Section 2, Section 3, and Section 7).

#### ITEM 4.1: FAO/WHO COORDINATING COMMITTEE FOR ASIA

#### Part 1 - Standards and related texts submitted for final adoption

Amendment of the labelling provisions for non-retail containers in the Regional Standards for Fermented Soybean Paste (Asia) (CXS 298R-2009) and Edible Sago Flour (Asia) (CXS 301R-2011), and the Standards for Gochujang (CXS 294-2009) and Chilli Sauce (CXS 306-2011) to align with the General Standard for the Labelling of Non-retail Containers of Foods (CXS 346- 2021)

# ITEM 8: APPLICATION OF THE STATEMENTS OF PRINCIPLE CONCERNING THE ROLE OF SCIENCE IN THE CODEX DECISION-MAKING PROCESS AND THE EXTENT TO WHICH OTHER FACTORS ARE TAKEN INTO ACCOUNT (SOP)

Indonesia appreciates the work done by the Chairperson and Vice-chairpersons in preparing this document to analyze comments from all members and observers regarding the Guidance on the Application of SoP. Indonesia hopes that the availability of this document will assist the decision-making process in Codex in the future.

Regarding the proposal for addressing the outstanding issues as included under each specific question as mentioned in the document CX/CAC 23/46/21, Indonesia has the following comments:

#### Should the guidance cover new work proposals?

The stage of reviewing a new work proposal is the initial phase of scrutinization to consider whether the proposed new work may potentially cause issues in the future. Therefore, Indonesia is of the view that this guidance document should also cover new work proposals. Indonesia believes that it is necessary so that issues related to OLF can be identified earlier.

## Considering the discussions on other legitimate factors during CAC45, is there a need for any further guidance on this aspect?

In relation to OLF, Indonesia believes that there are currently differing views among countries regarding what factors can be categorized as OLF. Therefore, Indonesia is of the opinion that further discussions on the definition of OLF and the criteria or examples of factors included in it, should be conducted at the Commission level.

#### Placement of the guidance

Indonesia supports that once the guidance finalised and endorsed, it should be included in the existing Codex Chairperson's Handbook and any future handbook for delegates.

#### ITEM 9: NEW FOOD SOURCES AND PRODUCTION SYSTEMS

Indonesia appreciates the analysis of the comments prepared by Chair and Vice-chairpersons as presented on the CX/CAC 23/46/22.

Indonesia has the same opinion that there is still range of views with regard to how Codex might work on NFPS. In line with the conclusions of CAC45, where the Commission could not find consensus on the need for a new cross-cutting coordination mechanism for NFPS, Indonesia believes that the current structure and mechanism of Codex is sufficient to cover issues related to NFPS. Indonesia also notes that based on the Codex Procedural Manual – Criteria for the establishment of subsidiary bodies of the Codex Alimentarius Commission, a new Codex Subsidiary Body is formed when there is a proposal for the elaboration of a standard, code of practice, or related text in area not covered by the terms of reference of any existing subsidiary bodies. Therefore, members who wish to propose a new work on NFPS could submit discussion papers and/or new work proposals either to existing Codex Committees or the CCEXEC for further consideration and final decision by CAC.
