### STATUS OF WORK ON THE REVISION OF CODEX STANDARDS FOR PROCESSED FRUITS AND VEGETABLES

(Prepared by the Codex Secretariat)

#### Introduction

1. This information is presented as a background document to provide the Committee with an update on the status of work of the revision of Codex standards for processed fruits and vegetables. The paper aims at assisting the Committee in planning its future work as regards the review of the remaining standards for processed fruits and vegetables and the uptake of work on new standards.
2. The 27<sup>th</sup> Session of the Committee (September 2014) could not consider this paper thoroughly due to time constraints. The Committee thus agreed to consider prioritization of work on the review of the remaining individual standards for processed fruits and vegetables including ways to deal with the standardization of dry and dried produce at its next session.
3. In order to assist the Committee in its deliberation on future work on the review of remaining standards for processed fruits and vegetables, the Committee agreed that the Codex Secretariat would proceed with the editorial amendment of the 18 standards awaiting review in particular with regard to the horizontal provisions applying across commodity standards, e.g. hygiene, contaminants, food additives, etc. The Committee further agreed that the section on food additives would be updated in line with the template laid down in the Procedural Manual, including a proposal for a general reference to the General Standard for Food Additives (CODEX STAN 192-1995).
4. The above approach would allow the Committee to focus its discussion on the technical provisions of the standards subject to review and to make an assessment on the need for their revision (whether full or partial). The editorial amendments to standards for processed fruits and vegetables are presented in working document CX/PFV 16/28/7-Add.1.<sup>1</sup>

#### Work output of the Committee on Processed Fruits and Vegetables in relation to the revision of standards for processed fruits and vegetables

5. Since the re-establishment of the Committee in 1998, the Committee has been revising and grouping, when possible and suitable, existing standards for processed fruit and vegetables into more general, horizontal standards.
6. This work follows the recommendation of the Codex Alimentarius Commission to review old Codex standards to determine the need for revision and to move towards the development of more horizontal standards when feasible and appropriate. This approach would facilitate the use of Codex standards by Codex member countries and with the general objective to facilitate international trade.
7. Most of the standards and related texts for processed fruits and vegetables were developed during the 70s and 80s. Work on the review since the re-establishment of the Committee has mainly been carried out on the revision of the standards for canned fruits and vegetables and lately on the standards for quick frozen vegetables. Some work on the conversion of regional standards into worldwide standards has also been undertaken. However, the main focus of the work remains the completion of the review and, if relevant, the revision of the existing individual standards for processed fruits and vegetables.

8. At its 25<sup>th</sup> Session in 2010, the Committee considered a report of a Working Group on Priorities on how to carry out future work on standards for processed fruits and vegetables. The Committee agreed to prioritize work on the development of standards for certain canned fruits and quick frozen vegetables.
9. The Chairperson of the Committee further noted that a great deal of work had already been done on the review and revision of individual Codex standards for processed fruits and vegetables. The Chair reminded the Committee that there was now a possibility to consider some work on the development of new standards while keeping focus on the review of the remaining standards in order to respond effectively to the needs of Codex member countries. The Chair thus invited Codex members to bring proposals for new work on standards for processed fruits and vegetables that might be of interest to their countries.<sup>2</sup>
10. At its 26<sup>th</sup> Session in 2012, the Committee considered the status of work on the review of standards for processed fruits and vegetables but decided not to take any new action in view of the following:
  - the ongoing revision of the remaining individual standards for canned fruits,
  - the existing individual standards for quick frozen vegetables,
  - the new work on conversion of the regional standard for ginseng products into an international standard, and
  - remaining issues surrounding packing media, food additives and methods of analysis in certain standards for processed fruits and vegetables that should be finalized by the 27<sup>th</sup> Session of CCPFV.<sup>3</sup>
11. At its 27<sup>th</sup> Session in 2014, the Committee finalized general provisions for canned fruits and specific provisions for some canned fruits as well as general provisions for quick frozen vegetables and specific provisions for some quick frozen vegetables. The Committee also finalized the conversion of the regional standard for ginseng products into a worldwide standard. The three standards were adopted by the 38<sup>th</sup> Session of the Codex Alimentarius Commission (July 2015) and are available as CODEX STAN 319-2015, CODEX STAN 320-2015 and CODEX STAN 321-2015 respectively.
12. In addition, the Committee finalized provisions for packing media in the Standard for Pickled Fruits and Vegetables and amended food additive provisions in a number of standards for processed fruits and vegetables. The 38<sup>th</sup> Session of the Commission also adopted these amendments.<sup>4</sup>

**Ongoing work in the Committee on Processed Fruits and Vegetables in relation to the revision of standards for processed fruits and vegetables**

13. At its 28<sup>th</sup> (present) Session in 2016, the Committee will consider finalization of the Annex on canned pineapples for inclusion in the Standard for Certain Canned Fruits (CODEX STAN 319-2015) as well as finalization of seven annexes on quick frozen vegetables for insertion into the Standard for Quick Frozen Vegetables. (CODEX STAN 320-2015) Discussion on these standards will include considerations of food additives and methods of analysis and sampling, the latter in particular in the Standard for Quick Frozen Vegetables (Agenda Items 3 and 4).
14. The Committee will also consider food additive provisions in several standards for processed fruits and vegetables arising from the Committee on Food Additives and other considerations arising from the 27<sup>th</sup> Session of CCPFV (Agenda Items 2 and 5).
15. The Committee will further consider queries from the Committee on Methods of Analysis and Sampling on sampling plans (ginseng products) and the replacement of Codex recommended methods (Codex RMs) with international validated methods developed by recognized international organizations for endorsement by CCMAS. It is noted that most of RMs were developed by CCPFV in the framework of the development of standards for processed fruits and vegetables (Agenda Item 2).
16. In addition, the Committee will consider how to approach the review of the existing standards for dry and dried produce and how to approach the up-take of new standards within this set of products vis-à-vis prioritization of work on other sub-sets of products (Agenda Items 6 and 7).

## Pending work on the review / revision of Codex standards for processed fruits and vegetables

### Ongoing work on canned fruits and quick frozen vegetables

17. The Standard for Certain Canned Fruits currently groups existing individual standards for canned mangoes, pears and pineapples. The structure, which contains general provisions applicable across canned fruits, followed by annexes addressing specific issues related to singular products, would allow further additions of new canned fruits in the future. This approach is also consistent with the one taken in the development of the Standard for Certain Canned Vegetables.
18. The finalization of the Standard for Certain Canned Fruits will lead to a few canned fruit standards e.g. canned berry fruits, canned fruit salads (mixed fruits), etc. and a few very specific canned standards, e.g. canned chestnuts and chestnut puree, mango chutney, etc., for review and subsequent revision by the Committee if appropriate.
19. The Standard for Quick Frozen Vegetables also follows the approach taken in the development of the standards for canned fruits and canned vegetables and comprises in total eleven annexes specific to some quick frozen vegetables.
20. The finalization of this Standard will conclude work on the revision of the existing individual standards for quick frozen vegetables.

### Remaining work on canned fruits and quick frozen fruits

21. The 25<sup>th</sup> session of the Committee noted the proposal of the working group on priorities regarding prioritization of future work on the development of standards for canned berry fruits, quick frozen fruits and canned mixed fruits following completion of standards for certain canned fruits and certain quick frozen vegetables.<sup>5</sup>
22. Based on the outcome of its 25<sup>th</sup> session, the Committee may wish to reflect whether it is appropriate to follow-up with work on the development of some or all of the standards listed in paragraph 21.
23. In considering future work on the development of horizontal standards for these commodities, the Committee may also wish to reflect on the following:
  - *Canned berry fruits* – whether the revision should address only the existing individual standards for some canned berries or whether there might be an opportunity to include other relevant berry fruits in the development of a more comprehensive horizontal standard for these products.
  - *Quick frozen fruits* – the same consideration presented for canned berry fruits applies.
  - *Canned mixed fruits* – international trade for canned tropical fruit salad and canned fruit cocktail is well defined. However, the Committee may wish to consider whether some other combinations of mixed fruits are available at present in international trade for inclusion in a standard for mixed canned fruits or to merge both standards while keeping well define the characteristics proper to fruit cocktail and tropical fruit salads

### Other processed fruits

24. The Committee may wish to consider how to approach the review of the remaining standards for canned chestnuts and chestnut puree, mango chutney and pickled cucumbers<sup>6</sup>.

#### *Pickled Cucumber*

25. The Standard for Pickled Fruits and Vegetables specifically excludes pickled cucumber from the scope. The Committee may wish to consider the priority for review of this standard in order to determine the need for their revision and the appropriateness to merge it with the Standard for Pickled Fruits and Vegetables.

Mango Chutney

26. As regards mango chutney, the Committee may wish to consider the possibility to develop a general standard for chutneys to cover fruits and vegetables either together or separately. An alternative approach could be the revision of the standard for mango chutney only, on the understanding that, if a standard for chutneys is developed, the approach taken for the development of the standards for canned vegetables will be followed.

Other processed vegetables

27. The Committee may wish to consider how to approach the review of the standards for fungi and fungus products, edible and the standard for fungi, dried, edible to determine:
- (i) whether they could be combined into a single general standard for fungi and fungus products; or
  - (ii) whether they should be kept separated; and
  - (iii) the review of the standard for fungi, dried be carried out in the framework of the review of the standards for dry/dried produce.

Dry/dried produce

28. This item is examined under Agenda Item 6.

Codes of hygienic practice

29. There are a number of codes of hygienic practice whose revision will be taken up by the Codex Committee on Food Hygiene e.g. Code of Hygienic Practice for Canned Fruit and Vegetable Products, Code of Hygienic Practice for Dried Fruits, Code of Hygienic Practice for Desiccated Coconut, Code of Hygienic Practice for Dehydrated Fruits and Vegetables including Edible Fungi, Code of Hygiene Practice for Tree Nuts, etc. These Codes have been included in the CCFH Forward Workplan.<sup>7</sup> The Code of Hygienic Practice for Low-Moisture Foods (CAC/RCP 75-2015), could include some the commodities from the above-mentioned standards. Therefore, no action is required from the Codex Committee on Processed Fruits and Vegetables in relation to the revision of these codes.
30. The table below shows the pending work on existing individual Codex standards for processed fruits and vegetables.
