#### Item 3 Proposed Codex General Principles of Meat Hygiene

The proposed draft Codex General Principles of Meat Hygiene, submitted for preliminary adoption by the 8<sup>th</sup> CCMPH (ALINORM 03/16, para.27), was adopted at Step 5 and advanced to Step 6 by 50<sup>th</sup> Session of the Executive Committee (June 2002) (ALINORM 03/3A, para. 71 and Appendix II).

Comments submitted at Step 5 and 6 in response to CL 2002/06-MPH and CL 2002/31-MPH are summarised in working paper CX/MH 03/3

#### Item 4 Proposed Draft Code of Hygienic Practice for Fresh Meat (CX/MPH 03/4)

The 8<sup>th</sup> CCMPH agreed that a drafting group would prepare a revised version of the proposed draft Code of Hygienic Practice for Fresh Meat based on the discussion at the meeting, written comments submitted in response to CL 2002/06-MPH and the proposed draft General Principles of Meat Hygiene. It was further agreed to circulate the revised version for additional comments before the 5<sup>th</sup> CCMPH (ALINORM 03/16, para. 76-77).

### Item 5 Annexes and additional provisions to the Proposed Draft Code of Hygienic Practice for Fresh Meat

The 8<sup>th</sup> CCMPH noted the offer of New Zealand, with the assistance of the Codex Secretariat, to prepare two separate discussion papers for consideration at its next session on the possible additional of Annexes to the proposed draft Code of Hygienic Practice for Fresh Meat. In this regard, the Committee noted that the proposal would be subject to approval as new work by the 50th Executive Committee. (ALINORM 03/16, paras. 78-79).

Furthermore, the 8<sup>th</sup> CCMPH requested that a discussion paper be prepared by New Zealand in Cooperation with the Codex Secretariat, on hygienic provisions for processed meat for potential inclusion in the Code for circulation, comments and further consideration at its next meeting (ALINORM 03/16, paras. 84-86).

The 50<sup>th</sup> Session of the Executive Committee noted that although the addition of appendices to a code under development did not generally require approval as new work, the Committee on Meat and Poultry Hygiene has sough such approval in view of the substantial work involved and to expedite the elaboration process in the Committee. The Executive Committee therefore approved as new work the elaboration of the following appendices to be included in the Code (ALINORM 03/3A, par. 84).
