

Implementation of the Codex Strategic Plan 2020-2025

(Prepared by the Coordinator for Near East and the Codex Secretariat)

1. Introduction

- 1.1 The FAO/WHO Coordinating Committee for the Near East at its 10th Session (CCNE10, 2019)¹ discussed the roadmap to implementation of the Codex Strategic Plan (2020-2025) and established an in-session working group (WG)², that agreed to prioritize objectives under Goals 2, 3 and 4 for 2020-2021 and identified a series of relevant activities for this scope. The Chairperson of the WG also proposed that the Committee closely review the table in order to ensure the proposed activities were aligned with such Goals and complemented by outputs and reporting mechanisms.
- 1.2 The WG prioritized activities under Goals 2, 3 and 4 for 2020-2022 for the Region including the following:
 - Goal 2: Develop standards based on science and Codex risk-based principles. The WG proposed that activities for the region in the period 2020-2021 should focus on the collection of recent scientific information on monitoring of contaminants (e.g. mycotoxins); and that an expert working group should be established to address critical and emerging issues discussed in Codex committees. Such a group could also facilitate more adequate preparation for Codex meetings by Members and increase submission of information to technical committees; to work with regional organizations to source funding to support expert meetings in the region to develop national and regional positions; and the expected outputs from the above activities would be reported to CCNE11.
 - **Goal 3: Increase impact through the recognition and use of Codex standards.** The WG considered it an important step towards the identification of the regional contribution to the implementation of the Codex Strategic Plan 2020-2025, noting the offer of the Kingdom of Saudi Arabia, who was nominated as the next Coordinator of the region, to provide resources to support implementation of the identified activities.
 - Goal 4: Facilitate the participation of all Codex Members throughout the standard setting process. Members added the use of available tools (FAO/WHO Diagnostic Tool) to assess national Codex structures as an activity to enable sustainable national Codex structures in all Codex Member countries (objective 4.1), and agreed that the expected output from this activity was the application of this tool by 25 percent of Members from the region by 2021. Holding a workshop with the support of the Codex Secretariat to build capability and enable effective participation in the Codex Alimentarius Commission of Member States, and a workshop to present information and guidance and applications to countries eligible for support from the Codex Trust Fund (CTF) were also identified as important activities.

1.3 CCNE10:

- expressed commitment to support the implementation of the Codex Strategic Plan 2020-2025;
- agreed that CCNE would focus on the implementation of activities aimed towards achieving Goals 2 (standards based on science and risk analysis), 3 (use of Codex standards) and 4 (participation) of the Strategic Plan 2020-2025 over the next two years; and

 agreed to submit a list of activities and related information that would be undertaken by the region over the next two years to the CCEXEC sub-committee on strategic planning for inclusion in the overarching work plan of the Strategic Plan 2020-2025.

2. Progress in implementing the Regional Work plan for 2020-2022

- 2.1 Significant progress has been made under the leadership of the regional coordinator in the implementation of the work plan agreed by CCNE10 despite the challenges caused by the COVID19 pandemic which led to implementation delays. Among as the following:
 - i. Updating of the contact list for each Member
 - ii. Contributing to implementing the Regional Communications Work plan
 - iii. Strengthening of the National Codex Committees (NCC) and increased participation of its members in various Codex meetings and activities, including the observance of World Food Safety Day, which was organized through the Regional Coordinator office.
- 2.2 CCNE Members continued to actively participate in and contribute to Codex work at the global level, using the possibilities the virtual platforms provided to the maximum extent. As such, the region has significantly contributed to the implementation of the Codex strategic plan at the global level, and major achievements are outlined in Annex I.
- 2.3 In addition a review of the progress made in implementing the Communications work plan agreed by CCNE10 has been undertaken by the Codex Secretariat (See Annex III). To complete the review of progress on communications all Members are invited to complete a short survey available here. More information is provided in Annex III.

3. Next steps for the region

- 3.1 Progressing the implementation of the Codex strategic plan, and continued active participation of the region in all Codex meetings are key goals moving forward.
- 3.2 A series of roundtable meetings are set to be held to support members of the region to effectively participate in the future Codex meetings under the Codex capacity building initiative in the region.
- 3.3 Ongoing collaboration work between the National Codex Committees (NCCs) and Government Departments in ensuring National Food Safety Standards, for example, Saudi FDA has launched a Healthy Food Strategy (HFS) with a vision of "A healthy nutrition pattern contributes to the promotion of public health" is key to not only ensuring engagement in standard development but also in standard implementation.
- 3.4 With these aspects in mind an updates work plan has been developed by the Regional Coordinator and this is proposed for consideration by CCNE11 as a basis for strategic plan implementation in the region over the next two years.

4. Recommendations

CCNE11 is invited to consider the report and

- i. advise on any additional activities that may have been implemented to support the implementation of the Codex Strategic Plan 2020-2025 (Annex 1), for example use of the FAO/WHO diagnostic tool or data collection initiatives at the national level.
- ii. Review and revise as appropriate the work plan for 2023-2025
- iii. Consider the report on the communications work plan, provide any further information and review and revise the work plan

CODEX COMMUNICATION PLAN

1. INTRODUCTION:

1.1 CCNE10 acknowledged the importance of prioritizing regional Codex communications and adopted the regional communications work plan 2020-2025 with the objectives of establishing clear communication channels and communicating the value of Codex Standards in the region. This work plan was linked to the efforts of the region to support implementation of Strategic Goal 3 of the Codex Strategic Plan 2020-2025 "Increase impact through the recognition and use of Codex standards"; in particular objective 3.1 "Raise the awareness of Codex standards". This paper highlights the progress made on implementation of the regional communications work plan and proposes that the region maintain such a work plan moving forward.

2. SUMMARY OF PROGRESS:

Objective 1: Establish clear, communication channels

- 2.1 The Coordinator has worked to continue communication among members in the region by means of WhatsApp, emails, telecommunications, and informal meetings.
- 2.2 It is also important that Members ensure that the official contact detail of their Codex Contact Point are up to date as this ensures that they receive formal communications from the Codex Secretariat. Updates can be provided directly to Codex@fao.org. It is essential that aAll requests to update the details of Codex Contact Points should be accompanied by a signed letter from the relevant government entity to ensure the authenticity of the request.
- 2.3 CCNE11 set a target that by CCNE11 75% of Members/Observers surveyed would indicate timeliness, accessibility and quality of Codex regional communications "excellent" or "good". To facilitate receipt of information on this, a very short survey has been developed. Members are encouraged to complete this survey at:

Objective 2: Communicate the value of Codex standards in the region

- 2.4 The proposed activities under this objective primarily related to sharing information related to success stories in the region, stories on food safety, standards work or capacity development initiatives in the region and activities undertaken under Codex Trust Fund (CTF) projects. There has been an effort in the region to document and communicate activities through the preparation of short web stories that have been subsequently published on the CCNE news page on the Codex website. This has been steadily increasing year on year.
- 2.5 Over the past 4 years, World Food Safety Day had provided a strong incentive to raise awareness on food safety and share information on national and regional initiatives. At least 12 countries³ in the region have shared stories since CCNE10, multiple stories coming from some countries⁴. In this context the region has

exceeded its target of 50% of countries contributing to news items and World Food Safety Day was the major driver. This year there was a strong focus on Codex standards on many of the activities and related news. The stories also covered some of the national initiatives in the area of food safety. This latter area is one where there is the opportunity for further expansion as it also provides valuable information about key achievements in the member countries on food safety issues, beyond awareness raising and training. There is also the opportunity for more countries in the region to share their experience. As there has been a year on year increase in the number of stories shared, the aim for the region can be to continue this upward trend and also to look for opportunities beyond WFSD to share their stories.

3. CONCLUSION AND RECOMMENDATION

3.1 In general, the region has made good progress on communications since CCNE10 with approximately half the region engaged in communications. World Food Safety Day, and the efforts of the Regional Coordinator have been key to making this progress. As there has been a year on year increase in the number of stories shared, the aim for the region can be to continue this upward trend and also to look for opportunities beyond WFSD to share their stories. Moving forward efforts should be made to continue to build in communications to all initiatives and to engage other members in the region to share their experiences.

- 3.2 In this context, it is recommended that CCNE11:
 - renew its commitment to the Communications work plan, as updated in Table 1;
 - · continue its efforts to enhance the regional communications network; and
 - continue to communicate on and promote its food safety and standard setting efforts and successes.
