#### NOTES ON THE PROVISIONAL AGENDA

#### Agenda Item 1: Adoption of the Agenda (Doc. Ref. CX/FA 12/44/1)

The Committee will be invited to adopt the Provisional Agenda, as contained in document CX/FA 12/44/1, as the Agenda for the Session.

Agenda Item 2: Matters Referred by the Codex Alimentarius Commission and Other Codex Committees and Task Forces (Doc. Ref. CX/FA 12/44/2)

Document CX/FA 12/44/2, prepared by the Codex Secretariat, includes matters referred to the Committee by the Codex Alimentarius Commission and other Codex Committees and Task Forces.

#### Agenda Item 2(a): Draft Risk analysis principles applied by the CCFA (Doc. Ref. CX/FA 12/44/3)

Document CX/FA 12/44/3, prepared by the Codex Secretariat, is a revision of the current *Risk Analysis Principles Applied by the Codex Committee on Food Additives and the Codex Committee on Contaminants in Foods*, where all references to CCCF have been deleted (*see* REP11/FA, para. 15).

Agenda Item 3: Matters of Interest arising from FAO/WHO and from the 74<sup>th</sup> Meeting of the Joint FAO/WHO Expert Committee on Food Additives (JECFA) (Doc. Ref. CX/FA 12/44/4)

Document CX/FA 12/44/4, prepared by FAO and WHO, includes matters from FAO and WHO and from the 74<sup>th</sup> JECFA meeting referred to the Committee for information and action.

Agenda Item 4(a): Endorsement and/or revision of Maximum Levels for Food Additives and Processing Aids in Codex Standards (Doc. Ref. CX/FA 12/44/5)

Document CX/FA 12/44/5 compiles food additive and processing aid provisions in draft and proposed draft commodity standards submitted by various Codex Committees to the CCFA for endorsement.

Agenda Item 4 (b): Discussion paper on the alignment of the food additive provisions of the standards for meat products and relevant provisions of the GSFA (Doc. Ref. CX/FA 12/44/6)

The discussion paper presents a proposal for the alignment of the food additives provisions of the five Codex commodity standards for meat products with the relevant provisions of the GSFA (*see* REP11/FA, para. 49).

#### Codex General Standard for Food Additives (GSFA)

Agenda Item 5 (a): Pending draft and proposed draft food additives provisions and related matters (Doc. Ref. CX/FA 12/44/7)

This item refers to pending draft and proposed draft provisions and related matters that have not been considered by the 43<sup>rd</sup> CCFA due to time constraints (*see* REP11/FA paras 73 and 74). Document CX/FA 12/44/7 compiles: (i) pending proposals included in document CX/FA 11/43/9; and (ii) comments and information on several food additives (replies to CL 2010/7-FA, Part B and CL 2010/39-FA).

Agenda Item 5 (b): Comments and information on several food additives (replies to CL 2011/4-FA, Part B, points 9, 10 and 11) (Doc. Ref. CX/FA 12/44/8 and REP11/FA Appendices VI and VII)

Document CX/FA 12/44/8 compiles replies to CL 2011/4-FA, Part B, namely:

<u>Point 9</u>: comments at Step 3 on provision for cassia gum (INS 427) in Table 3 and information on its use and use levels in food categories listed in the Annex to Table 3;

<u>Point 10</u>: Comments at Step 6 and 3 on several draft and proposed draft provisions: erythrosine (INS 127); lauric arginate ethyl ester (INS 243); steviol glycosides (INS 960); sulfites (INS 220-228, 539) in Table 1 and Table;

Point 11: additional information on specific provisions for steviol glycosides (INS 960) in Table 1 and Table 2;.

The document also includes replies to CL 2011/17-FA concerning the draft provision for carotenoids in food category 02.1.2 "Vegetable oils and fats".

Agenda Item 5 (c): Draft and proposed draft food additive provisions (provisions in Table 1 and 2 of Table 3 food additives with "acidity regulators and "emulsifier, stabilizer and thickener" function) (Doc. Ref. CX/FA 12/44/9 and CX/FA 12/44/9 Add.1)

Document CX/FA 12/44/9 compiles Table 1 and 2 draft and proposed draft provisions of "acidity regulators" and "emulsifiers, stabilizers, thickeners" Table 3 food additives. Document CX/FA 12/44/9 Add.1 is a proposal for a horizontal approach for consideration of these provisions (i.e. identifies those food categories in the Annex to table 3 in which the use of acidity regulators" and "emulsifiers, stabilizers, thickeners" is technologically justified and those food categories in which it is not) (*see* REP 11/FA paras 71-73). Comments at Step 6 and Step 3 are compiled in document CX/FA 12/44/9 Add.2.

#### Agenda Item 5 (d): Provisions for aluminium containing food additives (Doc. Ref. CX/FA 12/44/10)

Document CX/FA 12/44/10 includes a revised compilation of proposals for the revision of the aluminium containing food additive provisions, presented at the 43<sup>rd</sup> CCFA and recommendations for adoption, discontinuation or revocation of proposals, including those for new uses (*see* REP 11/FA para. 91).

### Agenda Item 5 (e): Discussion paper on description of food category 16.0 of the GSFA (Doc. Ref. CX/FA 12/44/11)

The discussion paper presents detailed description of the products to be included in food category 16.0 and proposals for the revision of the name and descriptor of the food category as necessary (*see* REP11/FA, para. 106).

#### Agenda Item 5 (f): Discussion paper on use of note 161 of the GSFA (Doc. Ref. CX/FA 12/44/12)

The discussion paper is a further revision of the discussion paper presented at the 43<sup>rd</sup> CCFA and includes recommendations to facilitate a uniform implementation of Section 3.2 of the Preamble of the GSFA to address the use of Note 161 (*see* REP11/FA, para. 114).

Agenda Item 6: Draft revision of the *Standard for Food Grade Salt* (CODEX STAN 150-1985) (N08-2010) (Doc. Ref. REP 11/FA App. IX and CX/FA 12/44/13)
