BACKGROUND

1. The 33rd Session of the Committee on General Principles (CCGP33), following its discussion on the proposed update to the Codex Procedural Manual's Guide to the procedure for the amendment and revision of Codex standards and related texts, requested the Codex Secretariat to prepare a Circular Letter (CL) for distribution to all Members and Observers to collect comments on the proposed amendments included in Appendix III of REP23/GP, for consideration by CCGP34.

REQUEST FOR COMMENTS

4. Codex Members and Observers are invited to review the proposed updates to Section 2 Elaboration of Codex standards and related texts, Part 7 on Procedures for the elaboration of Codex standards and related texts, and any related paragraphs, and provide comments on:
 - The appropriateness and clarity of the revisions
 - Whether there are any other parts of the text of Part 7 that would benefit from revision for clarity
 - Whether Part 7 could be further simplified
5. Comments are also requested on the proposed updates to the related paragraphs in the PM as follows:
 - Section 2 Elaboration of Codex standards and related texts, Introduction, paragraph 8
 - Section 2 Elaboration of Codex standards and related texts, Part 2. Critical Review, paragraph 12
6. Are there other texts of the PM that would need to be updated in light of the proposed updates to Section 2?
