  - c. the proposed draft revised *General Guidelines on Sampling* (CXG 50-2004) (Appendix IV) (at Step 5).

- 4. Comments should address whether the methods of analysis / texts are ready for adoption or not: and if not, provide the rationale and proposals to facilitate adoption. Comments should be provided in conformity with the Procedure for the Elaboration of Codex Standards and Related Texts (Part 3 – Uniform Procedure for the Elaboration of Codex Standards and Related Texts, Procedural Manual of the Codex Alimentarius Commission.
