Final adoption of Codex texts

1. Draft standard for kiwifruit (CCFFV)

Indonesia could not support provisions allowing a tolerance for decay in "Extra Class". Decay and rot were serious defects that could affect the quality of kiwifruit, and at the end it could affect the safety of the fruit. The term of "Extra Class" should only be for superior produce, and its quality must be better than produce in other Classes in order to justify the high price. Therefore, Indonesia would like to make reservation on this provision if the Commission adopt the draft standard at step 8.

2. Draft standard for garlic (CCFFV)

Indonesia supports the adoption of the draft standard for fresh garlic at Step 8.

3. Draft standard for ware potatoes (CCFFV)

Indonesia supports the adoption of the draft standard for ware potato at Step 8.

4. Proposed draft standard for yam (CCFFV)

Indonesia supports the adoption of the proposed draft standard for yam at Step 5/8.

5. Draft code of practice on food allergen management for food business operators (CCFH)
