NOTES ON THE PROVISIONAL AGENDA

Item 11	Establishment of Codex Priority List of Pesticides: The elaboration of the Priority List corresponds to Step 1 of the Codex MRLs Elaboration Procedure. The Committee will consider the report of the in-session Working Group on Priorities (presented as a conference room document) based on CX/PR 13/45/14-Add.1 containing collated proposals for priority lists of pesticides based on comments submitted by Member Governments in reply to CX/PR 13/45/14.
Item 12	Outcome of the Pilot Project for JMPR Recommendation of MRLs before National Governments or Other Regional Registration Authorities for a Global Joint Review Chemical: This item should be considered in conjunction with Agenda Item 6(a) related to the consideration of proposed draft MRLs for sulfoxaflor retained at Step 4 by the 44 th Session of CCPR (REP12/PR, para. 94, Appendix VII).
