Introduction to the OIE and Codex Alimentarius Collaboration



Introduction the OIE and Codex Alimentarius Commissions (CAC) collaboration

The OIE and Codex have a long-standing collaboration in addressing the risks to human health and food safety

There is regular participation of Codex representatives in the OIE standard setting work and vice—versa, the OIE participates in relevant CODEX activities as well

The OIE addresses food safety related issues in its standard setting activities and works closely with CAC and its Committees and with other international organisations to promote safe international trade in animals and their products





What is the OIE mission? Sixth Strategic Plan



OIE mission and its 6th Strategic Plan

To protect and promote animal health and welfare worldwide. The OIE's primary mandate is to produce Codes and Manuals covering terrestrial and aquatic animals.

Sixth Strategic Plan (2016–2020) sets out three major objectives leading to economic prosperity and social and environmental well-being.

- Objective 1: Securing animal health and welfare by appropriate risk management
- Objective 2: Establishing trust through transparency and communication
- Objective 3: Ensuring the capacity and sustainability of Veterinary Services

Resolutions

Adopted by the World Assembly of OIE Delegates during their 85th General Session 21 – 26 May 2017:

- Resolution No. 38 Global action to alleviate the threat of antimicrobial resistance: progress and opportunities for future activities under the 'One Health' initiative
- Resolution No. 39 Public-Private Partnerships: expectations of private sector partners for international animal health and livestock development programmes

Including of VICH Outreach activities

- The objectives of 5th Cycle seminar:
 - Combatting AMR including the Tripartite activities, implementation of national action plans, the OIE database on the use of antimicrobial agents.
 - Convergence/harmonisation of authorization system of drugs and vaccines.
 - Antiparasitic resistance and challenges; quality of veterinary products including, identification of actions that could be done to fight against counterfeit medicines.
 - General principles and implementation of VICH guidelines, update on VICH Outreach Forum activities.
 - Experience-sharing and FP activities as well as discussion among countries in the region.

Outreach Forum

The VICH Outreach Forum (VOF) is a VICH initiative with the main objectives to provide a basis for wider international harmonization of technical requirements, to improve information exchange, and to raise awareness of VICH and VICH guidelines with non-VICH countries/regions.

Objectives of the OIE activities:

- Highlight the VICH Outreach Forum activities
- Provide support through OIE communications
- Support participation by Outreach Forum Countries and underline the need for sustainability
- VICH Outreach Forum is slowly growing -16 MCs and 3 Organisations



Outreach Forum

There is a strong interest among VICH Member Countries about how the appropriate withdrawal periods should be set up for any food producing animals

There are many different withdrawal periods for the same pharmaceutical product or its generic equivalent (this challenge was also underlined during one of the training seminars)

This is important especially for developing or low and middle income nations that may lack comprehensive regulatory systems and controls;



Information to OIE Member Countries

After the VICH Steering Committee (SC) and Outreach Forum (VOF) meetings, Summary Reports are sent to all 181 OIE Member Countries

Invitation letters sent to the OIE Delegates for VOF Member Countries, copied to Focal Points for Veterinary Products and Organisations: e.g. ASEAN, CAMEVET and UEMOA



Information to OIE Member Countries

After the recent meeting we circulated the following draft guideline for consultation :

« Studies to evaluate the metabolism and residue kinetics of veterinary drugs in food producing species: Marker Residue Depletion (MRD) studies to establish withdrawal period in aquatic species. (Draft VICH GL 57) ».

Open for comments until 15 June 2018



Tangible Benefit

In Argentina during the (34th SC and 8th meeting) from 27-28 February to March in 2017 a report was presented on a joint review initiative between Canada, Australia and New Zealand which reinforced the tangible benefit of the VICH work
