BACKGROUND

- 1. The 25th Session of the Codex Committee on Food Import and Export Inspection and Certification Systems (CCFICS25) considered a paper, <u>CX/FICS 21/25/9</u> prepared by Australia and Canada, on emerging issues and the future direction of CCFICS. It was noted that the purpose of this agenda item was to facilitate a strategic, outward looking discussion by routinely undertaking a global scan, to identify potential future issues, challenges and advancements on issues within the mandate of the Committee. This would ensure CCFICS is robust and strongly positioned to flexibly consider new work or revisions to Codex standards, in identifying and prioritising areas of future work.
- The Committee also agreed that Australia and Kenya would prepare an updated Appendix A of the paper on "Emerging issues and future direction of CCFICS, taking into account discussions at CCFICS25, as well as comments solicited through a Circular Letter, and submit an updated list of emerging issues to CCFICS26 for consideration".
- 3. The Committee noted that a working group meeting may be held prior to the next CCFICS session to prioritise new work in order to provide recommendations to the Plenary.

REQUEST FOR COMMENTS

- 4. Member governments and observers are invited to review Appendix A and provide comments on new emerging global issues for consideration. Comments should include additional detail on currently listed proposals in the table (including better defining how it relates to CCFICS) and/or striking proposals that may either no longer be relevant to the work of CCFICS or are not within CCFICS' mandate. Australia and Kenya, as Co-Chairs, have provided recommendations against some items that may either be removed and/or modified with support of other Members (refer highlighted text).
- 5. Member governments and observers are also invited to identify additional emerging issues in Appendix A that fall within the remit of the Committee. In identifying emerging issues and/or proposals for new work, members and observers should provide information in line with the criteria listed in the table in Appendix A.
- 6. Comments are requested to the addressees indicated above by 30 June 2022

(CX/FICS 21/25/9)

Introduction

- 1. The table below identifies significant emerging global issues that may impact the work of CCFICS and recognises any existing texts or new work proposals relevant to each issue. These items have been drawn from previous discussions at CCFICS sessions and other available material, including multilateral food safety and trade discussions.
- 2. It may be the case that existing texts touch on, but do not fully address, an identified global issue. In this case, additional or clarifying guidance may be warranted. This may present an opportunity for the Committee to consider the appropriateness and priority of potential new work, using the proposed framework outlined in Appendix B of document CX/FICS 21/25/9. It may also present an opportunity to review existing texts in light of new data, or new trading environments.
