**ANNOTATIONS TO THE PROVISIONAL AGENDA
for the Sixteenth Session of the Codex Committee on Fats and Oils
London, United Kingdom, 8-12 March, 1999**

- Item 3** **Revision of current Standards:** The Draft Standard for Named Vegetable Oils and the Draft Standard for Olive Oils and Olive-pomace Oils were returned to Step 6 by the Fifteenth Session of the Committee. The Commission returned the Draft Standard for Named Animal Fats and the Draft Standard for Fats and Oils not Covered by Individual Standards to Step 6 as objections were raised by a number of delegations.
- Item 4** **Draft Code of Practice for the Storage and Transport of Edible Fats and Oils in Bulk:** The Commission returned the Draft Code to Step 6 as a number of issues had not yet been resolved fully, in particular, the provisions relating to the use of thermal heating fluids.
- Item 5** **Proposed Draft Standard for Fat Spreads and Blended Spreads:** Due to the heavy agenda at the 15th Session of the Committee, it was only possible to discuss very briefly this Proposed Draft Standard. It was, therefore, returned to Step 3 for a further round of comments and for more detailed consideration.
