NOTES ON THE PROVISIONAL AGENDA

Item 1 Adoption of the Agenda (CX/MH 05/11/1)

In accordance with Rule V.2 of the Rules of Procedure, the first item on the Provisional Agenda shall be the adoption of the Agenda.

Item 2 Matters Referred from the Codex Alimentarius Commission and Other Codex Committees (CX/MH 05/11/2)

The document is an information paper prepared by the Codex Secretariat concerning matters referred and/or of interest from the Codex Alimentarius Commission and other Codex Committees.

Item 3 Draft Code of Hygienic Practice for Meat (ALINORM 04/27/16, Appendix II)

The 10th CCMH noted that considerable progress was made on the revision of the draft Code of Hygienic Practice for Meat, which now encompassed also provisions for processed meat. However some issues, especially on the fundamental definition of Veterinary Inspector and on Recall System required further consideration. It therefore agreed to return the draft Code to Step 6 for comments and further consideration at its next session. The Committee also agreed that Annexes on Risk Based Evaluation of Organoleptic Post-Mortem Inspection Procedures for Meat and on Microbiological Verification of Process for Control of Meat Hygiene would constitute an integral part of the draft Code (ALINORM 04/27/16, para. 49).

Comments submitted at Step 6 are summarised in document CX/MH 05/11/3.

Item 4 Other Business and Future Work

In accordance with Rule V.5 of the Rules of Procedure, any Member of the Commission may propose the inclusion of specific items of an urgent matter. The Committee may propose to undertake new work which shall be in compliance with the Medium Term Objectives and subject to the approval by the Commission or its Executive Committee.
