

CODEX STRATEGIC PLAN 2020 - 2025 - ROAD MAP TO IMPLEMENTATION

REPORT OF THE IN-SESSION WORKING GROUP

1. INTRODUCTION

- 1.1. An In-session Working Group (WG) was established by CCNE10 to consider CX/NE 19/10/10 and written comments and to prepare a report for consideration by the Plenary on the activities to be carried out in the region in the next two years to support implementation of the Codex Strategic Plan 2020-2025 (Appendix III of CX/NE 19/10/10).
- 1.2. The WG was chaired by Egypt. The Chairperson recalled that CAC42 had adopted the Strategic Plan 2020-2025 with the objective of advancing the Codex mandate and highlighting the mission and vision of Codex. He reminded participants of the importance of learning from the past noting that the lessons learned from the Strategic Plan 2014-2019 were important to ensure the successful implementation of the Strategic Plan 2020-2025 and avoid potential pitfalls. He reminded the WG that many parties had responsibilities towards achieving the strategic plan and Codex Members were among those with the highest responsibilities.
- 1.3. The Chairperson noted the need for a realistic work plan that could be implemented in the next two years, that was based on the priorities and needs for the region, and had a clear rational and approach to monitoring progress by 2021.
- 1.4. The Chairperson of the CCEXEC Sub-committee on strategic planning provided an overview of the work of the sub-committee and the expectations of CCNE vis-à-vis implementation of the strategic plan recalling the importance of inclusivity and collaboration. He highlighted the importance of identifying priority areas of work for the region and the need for clarity on time scale and ambition.

2. SUMMARY OF DISCUSSIONS

2.1. The discussions were facilitated and undertaken in several phases.

Phase 1: Identification of the priority goals for CCNE

2.2. Members were asked to review goals 1- 4 and identify their highest priority goal based on their experience and needs. Using this approach Goals 2, 3 and 4 were considered as the highest priority and the WG therefore focussed their next round of discussions on Goals 1, 2 and 3.

Phase 2: Identification of activities

2.3. Members worked in three sub-groups, each dealing with a different Strategic Goal and proposed the following practical and feasible activities to be implemented over the next two years.

 - i) consider and agree with the priority goals and objectives identified by the working group;
 - ii) consider the activities identified by the working group and provide feedback on their refinement and revision such as to ensure their implementation within the next two years; and
 - iii) further consider the mechanism by which the implementation on activities will be reported as this is critical to the monitoring of the progress made on the implementation of the strategic plan; and
 - iv) finalise the table above for inclusion in the report of this session.
