## IMPLEMENTATION OF THE JOINT FAO/WHO EVALUATION OF THE CODEX ALIMENTARIUS AND OTHER FAO AND WHO WORK ON FOOD STANDARDS

### **GENERAL IMPLEMENTATION STATUS**

- 1. The 26<sup>th</sup> Session of the Codex Alimentarius Commission (July 2003) examined specific proposals that had originated from the Joint FAO/WHO Evaluation of the Codex Alimentarius and other FAO and WHO Work on Food Standards<sup>1</sup>. The implementation status of those proposals endorsed by the 26<sup>th</sup> Session of the Commission and other decisions by the Commission related to the Joint FAO/WHO Evaluation is summarised in Tables 1 and 2.
- 2. The Commission is invited to take note of the progress being made and to provide any guidance deemed necessary to ensure the timely and continuous implementation of the proposals/decisions.
