## Terms and conditions of the International Year of Plant Health Art and Drawing Competition for children

## **GENERAL RULES**

- 1. FAO employees and their immediate family members (spouses, parents, children, siblings and their respective spouses, regardless of where they live) or persons living in the same households of such employees, whether or not related, are not eligible to enter the Competition. FAO and the Secretariat of the International Plant Protection Convention (IPPC) will determine eligibility at its sole discretion.
- 2. Partners or relations of partner staff of the institutions involved in the launch of the Competition, and relations of the judging committee are not eligible to compete.
- 3. FAO and the IPPC Secretariat reserve the right to disqualify submissions which are not consistent with the Organization's values and guiding principles.
- 4. FAO and the IPPC Secretariat also reserve the right to verify the eligibility of any entry and/or entrant (including an entrant's identity and address) and to disqualify any entrant who submits an entry that is not in accordance with the Competition Rules, including these Rules, Copyright and Privacy, or who tampers with the entry process.
- 5. FAO and the IPPC Secretariat will not pay any fees, nor pay any costs relating to, participation in any Competition or for the use of any submissions in relation to the Competition.
- 6. No logos, URLs, telephone numbers, or calls that solicit directly for monetary donations should be included in any material.
- 7. FAO and the IPPC Secretariat will not be responsible, and cannot be held liable, for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or for any human error, lost/delayed data transmission, or any other error or malfunction.
- 8. By submitting entries to the Competition, entrants agree that personal data, especially name and address, may be processed, shared, and otherwise used for the purposes and within the context of the Competition, FAO and the IPPC Secretariat institutional activities, and any other purposes outlined in these Rules. The data may also be used by FAO and the IPPC Secretariat in order to verify the entrant's identity, postal address and telephone number or to otherwise verify the entrant's eligibility to participate in the Competition.
- 9. Nothing in these General Rules or in any rules for the Competition, nor any acts performed or statements made in relation to the Competition, shall be deemed a waiver, express or implied, of any of the privileges and immunities of FAO.
- 10. Each entrant below legal age shall acquire, upon submission, the necessary consent and adherence to the Terms and Conditions set forth by this Competition from parents, guardians,

- custodians or whomever is legally charged with their legal supervision. Any submissions of entries and information should be supervised by an adult.
- 11.Institutions intending to subscribe their pupils to this Competition must acquire adherence to the Terms and Conditions set forth by this Competition from parents, guardians, custodians or whomever is legally charged with their legal supervision, particularly with regards to submission of any personal information regarding the entrants.

## **COPYRIGHT AND PRIVACY**

- 12.Entrants must own the copyright of the material they submit to the Competition. If the material contains images of a person or persons, entrants must have obtained the permission of those persons for submission of their material to the Competition as well as the use of the material by FAO and the IPPC Secretariat for the purposes described in these General Rules.
- 13. The entrant declares that, to the best of his/her knowledge, no third party can claim any rights on the material submitted. The entrant also confirms that each person depicted in the material has granted permission to be portrayed as shown.
- 14.FAO and the IPPC Secretariat will not seek additional approvals in connection with the use of the material and it will not be responsible for any claim or complaint alleging violation of the rights of third parties.
- 15. Copyright of the material remains with the entrants. By entering the Competition, entrants grant an irrevocable, perpetual, worldwide exclusive license to FAO and the IPPC Secretariat, for non-commercial purposes, to reproduce, distribute, display and create derivative works of the entries (along with a name credit) in connection with the Competition and the promotion of FAO and IPPC's work, in, amongst others:

  - corporate videos or digital recordings to illustrate the work of the Organization and the Convention;
