General Description of task(s) and objectives to be achieved

The Lead Consultant and Agriculture Adaptation Planning Expert is responsible for formulating, implementing, monitoring and reporting on the coordinated FAO and UNDP collaborative work-plan for Nepal. He/she will be under the overall supervision of the FAO Representative in Nepal and report to the overall Project Coordinator in FAO-HQ. The Lead Consultant will work in close consultation and collaboration with the Programme Unit of FAO Representation and Energy, Environment, Climate and Disaster Risk Management Unit of UNDP Country office in Nepal, the FAO Natural Resources Officer – Climate Change and Bioenergy for Asia and the Pacific and the UNDP-GEF Unit at the Bangkok Regional Hub. The consultant will also coordinate implementation of the project activities with the Project Steering Committee, the Technical Advisory Committee and other relevant national stakeholders.

The Lead Consultant and Agriculture Adaptation Planning Expert is expected to possess a strong mix of technical expertise as well as proven management capacity. S/he will assume the following job functions and responsibilities:

i. Overall management of project implementation

- Prepare, coordinate, update and manage the detailed FAO-UNDP national work plans and budget of the project, with clear timelines, milestones and deliverables, consistent with global reporting frameworks for project-level outcomes;
- Coordinate, supervise and lead overall implementation of project activities in close coordination with the respective units of FAO and UNDP Country Offices and UNDP and FAO designated consultants in a manner consistent with the global and national project logframe and work plan, and in compliance to guidance from the national project steering committee;
- Directly supervise staff hired by the project and at project activity sites;
- Ensure close coordination between other relevant FAO & UNDP projects and programmes particularly GCP/RAS/070/LDF "Reducing vulnerability and increasing adaptive capacity to respond to impacts of climate change and variability for sustainable livelihoods in agriculture sector in Nepal";

- Ensure that all reports, documents and other outputs prepared by service providers are of high quality and are targeted towards achieving project objectives as planned;
- Perform other related duties as required

ii. Technical assistance and adaptation planning advisory services

- Contribute technically to all outputs of the collaborative project work plan and provide technical leadership and direct inputs to the FAO designated outputs ;
- Review and conduct research on existing agriculture sector policies, plans and initiatives in particular Agricultural Development Strategy (ADS) of the Government of Nepal to technically guide the design and set-up of agricultural sector contributions (eg. stock-taking) to the overall NAP process in Nepal, building on existing policy, institutional and human resources capacities;
- Supervise a needs assessment exercise amongst key personnel to conduct national adaptation planning, budgeting, cost-benefit analysis, climate data modelling and scenario building for the agricultural sector, within the Ministry of Agricultural Development, Ministry of Livestock Development and related Planning, Finance, Disaster Management, Water and other related institutions to identify institutional capacity gaps as well as entry points to integrate climate change adaptation into agriculture sector planning processes;
- Based on a synthesis of methods and information on climate vulnerability in Nepal develop methods for Climate Change Adaptation (CCA) planning and budgeting for the agriculture sector and approaches for evaluating priority agricultural sector adaptation options;
- Organize, lead and participate in training and capacity building exercises on CCA and related project activities in target districts and regional and national training centers;
- Supervise and provide technical guidance for the implementation a programme monitoring framework including Key Performance Indicators for enhanced CCA and field monitoring of CCA in ADS priority programs;
- Contribute to technical content related to Nepal's experience on integrating agriculturalsector adaptation concerns into NAP processes (i.e, through policy briefs, handbooks, guidance papers, etc. as identified in the work plan;
- Support and promote gender equality and social inclusion in program activities as well as among the project staff.

iii. Monitoring, evaluation and reporting of the collaborative FAO-UNDP work-plan

- Formulate targets and key performance indicators for project outcomes and outputs in collaboration with UNDP and FAO Global teams.
- Report on and contribute information on project progress of the collaborative FAO-UNDP work-plan, key milestones and other relevant information (for annual report, audits, mid-term and terminal evaluations) to the global project team as per agreed timeline;
- Prepare key operational reports including an inception, mid-term and final report in addition to six-monthly progress reports, summarizing findings, achievements, conclusions and recommendations on the progress of the project in the country.

- Provide logistical and organizational support for in-country coordination meetings, capacity-building workshops and training sessions;
- Prepare documentation of coordination meetings, workshops, and trainings (including concept notes, invitation letters, lists of participants, etc);
- Prepare documentation and knowledge management of lessons learnt;
- Draft communication briefs and fact sheets etc for national media, in-country donor community, and other national-level entities.
