GENERAL DESCRIPTION OF TASK(S) AND OBJECTIVES TO BE ACHIEVED						

Under the direct supervision of the Project Livestock Specialist and in close coordination with the chief of the District Livestock Service Office and other district teams, the District Project Livestock Officer will be responsible for effective planning and implementation of livestock related activities under all 4 components of the project. Specific tasks of the position include:

- Assisting the DLSO in the preparation of farmer need based annual work and expenditure plans for the component and their dissemination;
- Providing adequate orientation to field based Livestock Technicians on project activity implementation, supervision and monitoring modalities;
- Assisting the DLSO to select the pockets for goat breeding program that meet the criteria set for this purpose such as; (i) area where stall feeding is a general practice, (ii) number of breedable female goats averages a minimum of 3 per HH, (iii) farmers have interest to undertake performance recording system, and (iv) the pockets so selected are within easy rich for supervision and monitoring;
- In close coordination with NARC, ensuring smooth implementation of goat breeding program, including timely and correct data collection, processing and dissemination;
- Ensuring that the goat breeder farmers sell the top 40 to 50 of top bucks to the project goat production groups, including assisting farmer groups to develop and implement buck management system;
- In close coordination with the Project Livestock Specialist, assisting DLSO in the selection of field level staff for FFS facilitation training and other training programs;
- Monitoring FFS activities and their facilitators and providing this information to the DLSO and the Project Livestock Specialist;
- Supporting DLSO in the identification and selection of appropriate groups to participate in FFS activities and participating in discussions and negotiations with Village Development Committees, and others involved in the establishment and facilitation of the FFS;
- Guiding the field based technicians to implement the livestock related activities, including identification of candidates for training of the Village Animal Health Workers, Village Poultry Assistants, hatchery operators, chick brooder, chick rearers, as appropriate and organization of training courses for this purpose, in close coordination with the DLSO, Project Livestock Specialist and the appropriate training institution;
- Organizing training of field staff in the use of FAMACHA cards to assess the heamonchus load in animals and treating them based on heamonchus load.
- Assisting DLSO to identify candidates for training in small scale dairy business development, and agro-vet business promotion and organization of training courses for these purposes, in close coordination with the Project Livestock Specialist and the appropriate training institution;
- Assisting DLSO to identify agro-vets and field staff in the related districts for training in Khari disease management in buffalo and organize training in coordination with NARC experts.
- Ensuring appropriate establishment of forage demonstrations on intensification of terrace risers and bunds for increased livestock feed supply, and their protection from grazing.
- Ensuring adequate and timely supply of forage seeds/saplings for both demonstration and dissemination;
- Ensuring that the fodder tree seedlings are planted timely and protected from animal grazing;
- Supporting DLSO and farmer groups to identify appropriate sources for supply of buffalo breeding bulls, including assisting farmers to develop and implement appropriate bull management system;
- Ensuring adequate and timely supply of semen for artificial insemination and vaccines like HS, BQ and FMD and PPR;
- Ensuring that the support services and inputs are adequately available to the poultry hatcheries.
- Ensuring that the chicks reaching the project beneficiaries are vaccinated against New Castle and Gumborro diseases.
- Ensuring appropriate management of Project supported funds Veterinary Drug, Animal Insurance Fund and Shed Improvement Fund as demonstration level;
- Assisting farmers in developing milk marketing linkages, including establishment of milk chilling centres in collaboration with the dairy industries;
- · Assisting farmers in developing organized goat marketing system including establishment of goat collection centres/hubs;
- Ensuring that the Project supported activities such as VAHW, paravets, local milk processors follow appropriate code of practices for environmental and public health safety;
- Ensuring that the training of the chilling centre managers in the operation and maintenance of chilling vats and local dairy products diversification are organized in appropriate locations and the resource persons used are professional;
- Supervising the activities of the field based technicians and other Assistants and ensure their adequate performance against targets;
- · Participating in annual or other periodic meetings with beneficiaries and other Project stakeholders at district and project area; and
- Other duties as instructed by the Project Livestock Specialist.
