ESA also leads large programmes at country level on the right to food, agricultural policy monitoring, climate smart agriculture, social protection, and food security information and analysis in support of national policies.

The Senior Economist will work in cooperation with other teams in the ES Department and in response to governmental requests.

Leadership and conceptual design for the development and implementation of comprehensive technical, statistical and/or analytical frameworks to support the programme of work and related products, projects and services in accordance with the FAO Strategic Framework.
