DUTIES AND RESPONSIBILITIES

Under the general direction of the Director, FOMD, the incumbent will be responsible for planning, organizing and coordinating the technical and operational delivery of the organizational results related to forest resources management. In particular, the incumbent will:

- Provide managerial and technical leadership, guidance and support to the Team in forest resources management, including multiple
 use forest management, fire management, planted forests, forest health, forest genetic resources, agroforestry, trees outside forests,
 forest restoration and inter-sectoral dimensions of forest resources management in all ecotypes, including fragile ecosystems and arid
 and semi-arid forestry;
- Coordinate and harmonize international, national and sub-national efforts for forest resources management to adapt to and mitigate climate change;
- Provide advice to FAO member countries in strengthening their capacity to manage forest and tree resources sustainably;
- Plan, allocate resources, implement, monitor and report upon the technical, operational and financial delivery of unit results of the Team
- Foster, strengthen and manage strategic partnerships with relevant institutions at international, national and local levels, including the
 private sector, NGOs and donors dealing with matters related to the functions of the Task Force;
- Provide guidance and supervision to Task Force personnel to strengthen their knowledge and skills in forest resources management;
- Plan and supervise the secretariat services to the Statutory Bodies of the International Poplar Commission and Silva Mediterranean;
- Promote resources mobilization for programmes and projects in forest resources management;
- · Perform other related duties as required.

MINIMUM REQUIREMENTS

Candidates should meet the following:

- Advanced University Degree in Forest Resources Management or a related field
- · Ten years of relevant experience, including field experience, in programme planning and delivery in forest resources management
- Working knowledge of English, French or Spanish and limited knowledge of or one of the other two or Arabic, Chinese, Russian

- Extent and relevance of work experience related to forest resources management programming, planning and delivery in development organizations, including international agencies
- Demonstrated results-based management capabilities with an ability to manage programmes, budgets, and human resources

- Extent and relevance of analytical experience related to forest resources management
- Relevance and level of academic qualifications
- Quality of written and oral communication and negotiation skills
- Extent and relevance of publications record
- Demonstrated ability in leading and working successfully in multicultural and multi-disciplinary teams
