- Provides regional project coordination: coordinates the development of project work plans, budgets and implementation plans, monitors project progress, ensures the day-to-day management of the project and acts as Secretary to the Project Steering Committee (PSC) and chairs the Technical Committee;
- Supervises the national project coordinators in the nine project countries and ensures coordination and information exchange between them;
- Develops specifications for, and supervises implementation of, contracts and Letters of Agreements with project partners, service providers and individual consultants as per FAO terms and conditions;
- Consolidates all reports and outputs from the component teams and prepares and submits project narrative, financial and cofinancing reports; and drafts budget revisions to the FAO Lead Technical Officer and Budget Holder, as appropriate and in line with GEF guidelines;
- Promotes south-south skill sharing and capacity building with other GEF projects implemented in Benin, Cameroon and Morocco on pesticide risk reduction to support project activities specifically for the recruitment of consultants, purchase of equipment, establishment of international contract for disposal, training and study tours;

- Liaises with regional and national stakeholders, regional partners and donor representatives, in particular with the GEF and the regional organizations active in the region;
