## **Organizational Setting**

The Animal Health Service (AGAH) of the Animal Production and Health Division (AGA) is primarily concerned with aspects related to the prevention, detection and timely response to high impact and zoonotic diseases and other global health threats such as antimicrobial resistance (AMR). AGAH is the technical lead of the Emergency Centre for Transboundary Animal Diseases (ECTAD), a global platform that supports the Emergency Prevention System for Animal Health (EMPRES) to effectively prevent and respond to persisting and/or spreading transboundary animal diseases at a global level, with emphasis on developing countries. The post is located within the ECTAD Programming Unit (PU). This unit serves as an interface between the technical and normative strategies developed within AGA and the Organization's operational response to emergencies coordinated by the Emergency and Rehabilitation Division (TCE). The PU's core mandate encompasses strategic planning, operational programming, projects and programme quality assurance, and liaison with key funding partners. The unit facilitates and develops new collaborations with strategic funding partners such as the US Defense Threat Reduction Agency (DTRA). FAO and DTRA partnership builds upon the intersection of the respective mandates in the domain of global prevention of zoonotic diseases and other disease threats. The post will act as focal point for all DTRA grants contributing to the development of FAO-DTRA partnership in support of biothreats reduction programmes.

# **Reporting Lines**

The Programme Officer reports to the Senior Animal Health Officer (TADs, Programming) and works in close collaboration with the Deputy Head of ECTAD Operations.

#### **Technical Focus**

Programme/project management, AMR global programme and biothreats reduction operations, programming and capacity development support, grant negotiations, donor liaison.

# **Key Results**

Develop, implement, monitor and evaluate assigned programme/projects.

### **Key Functions**

- Participates in the development, implementation and evaluation of assigned programmes/projects, etc.; monitors and analyzes programme/project development and implementation;
- Reviews relevant documents and reports; identifies problems and issues to be addressed and proposes corrective
  actions; liaises with relevant parties; identifies and tracks follow-up actions;
- Assists in policy development, including the review and analysis of issues and trends, preparation of impact evaluation or equivalent studies, etc.;
- Prepares various written outputs, e.g. drafts background papers, analysis, sections of reports and studies, inputs
  to publications, etc.;
- Undertakes outreach activities; conducts training workshops, seminars, etc.; makes presentations on assigned topics/activities;
- Coordinates activities related to budget and funding (programme/project preparation and submissions, progress reports, financial statements, etc.) and prepares related documents/reports (pledging, work programme, programme budget, etc.).

## **Specific Functions**

- Coordinates the negotiation of DTRA proposals, acting as a focal point for all aspects related to the grant awarding process and project implementation;
- Provides programmatic expertise in the formulation of proposals for DTRA awarding, throughout all the stages of the process (pre-coordination, proposal development and review/evaluation);
- Manages DTRA grants and oversees the delivery and approval of expenses in compliance with specific donor requirements;
- Manages the operations of the FAO component of the AMR Tripartite global programme, ensuring effective implementation and coordination at all levels to identify timely solutions for any complex situations concerning coordination of AMR programme implementation among internal and external partners;
- Advises and supports relevant budget holders to ensure budgeting and administration are effective and in line with both donor-specific requirements and FAO policies;
- Analyses projects' financial data, delivery estimates, and actual expenditures through continuous monitoring of transactions to inform timely corrective action;
- Coordinates the preparation/ submission of projects reporting and prepares donor-specific financial reports, in liaison with Finance Department, ensuring quality review and overseeing compliance with donor requirements:
- Participates in support missions to provide backstopping and promotes best practices to Decentralized Offices in project formulation and management.
