**GENERAL DESCRIPTION OF TASK(S) AND OBJECTIVES TO BE ACHIEVED**

In close collaboration with the MoFALI and the World Bank, under the operational Supervision of the FAO Representative (FAOR) in Mongolia and Assistant Technical Adviser (ATA), as well as the technical supervision of the Lead Technical Unit, the Meat Trade Specialist will be responsible for the first two activities of the animal health subcomponent, that is, definition of 'roadmap' for unrestricted meat export and progressing export agreements for commodity-based trade. Specifically, the consultant will:

- Assess the current status of progress towards achieving unrestricted meat export;
- Identify pathways to achieve unrestricted meat exports (i) from Mongolia; and (ii) from a specified zone of Mongolia, including the specific steps that would need to be taken to achieve these goals;
- With the CVO, review progress with meeting the two OIE missions' recommendations for further actions to facilitate trade in meat and meat products;
- Advise the national consultant on requirements for upgrading border inspection posts (BIPs) and Arkhangai buffer zone check post, making field visits as necessary;
- Identify gaps and obstacles limiting Mongolia's access to export markets for meat and meat products that are not yet addressed by this or other projects;
- Assist the CVO to draft detailed, time-bound plans to overcome these obstacles so that s/he can seek support from the Government of Mongolia, through this project or through requests to other donors to achieve the goal of unrestricted meat export;
- For bilateral, commodity-based trade agreements, train trade negotiators on the World Trade Organization's (WTO) Sanitary/Phytosanitary (SPS) agreement, and countries' rights and responsibilities;
- Support and / or facilitate intergovernmental technical meetings to progress agreements

- between Mongolia and potential importing countries;
- Provide technical assistance to national enterprises to develop their market chains with a view to exports of meat and meat products
