DUTIES AND RESPONSIBILITIES

Under the direct supervision of the FAO Representative in Hanoi, the technical guidance of the Lead Technical Officer (LTO) at FAO Headquarters, and in coordination with the National Project Coordinator (NPC), the incumbent will provide technical assistance and support to the Ministry of Agriculture and Rural Development (MARD) and Forest Inventory and Planning Institute (FIPI) in the areas of capacity building, institutional strengthening, planning and implementation of the Support to National Assessment and Long Term Monitoring of the Forest and Tree Resources in Vietnam (NFA) project. In particular, will:

- In collaboration with the national counterpart prepare work-plans for office and field activities of forest resources assessment;
- Work closely with the national counterpart personnel to refine the approach to national forest and tree inventory based on the model approach
 of FAO including needs of REDD+ monitoring and taking into account the existing national sampling design.
- Participate in the elaboration of a training programme to be dispensed to national project staff in the office and in the field involved and assist
 the MARD/FIPI in implementing it.
- In collaboration with national counterpart personnel and other national and international personnel, strengthen FIPI for future monitoring of the
 resources and information management.
- Participate in planning, running and servicing the workshops and seminars in connection with the field of expertise (informative seminar on the NFA approach, workshops on information and capacity building needs, project findings).
- Secure wide consultation in order to establish national consensus on the NFA approach and long term monitoring.
- Identify equipment and supplies for the forest inventory component of the project for procurement.
- Organise and conduct fieldwork.
- Technically supervise field crews during the survey, especially during the start of fieldwork, and provide technical guidance in order to homogenise data collection and interpretation of variables and definitions.
- Organise, analyse and report on field crew outputs.
- Prepare project progress reports on the component of inventory and the end of mission report.
- Provide support to other FAO-Finland Cooperation Programme activities in Vietnam.
- Perform other related duties as required.

MINIMUM REQUIREMENTS

Candidates should meet the following:

- Advanced University Degree in Forestry or related subject
- Seven years of relevant experience in the field of forest management, forest resources monitoring and assessment
- Working knowledge of English

- Relevance of experience in capacity building and project implementation

- Relevance of experience with UN, intergovernmental and international organizations related to forestry
- Relevance of academic qualifications
