#### DUTIES AND RESPONSIBILITIES

Under the direct supervision of the Sub-Regional Coordinator, the incumbent will be travelling to other Caribbean countries, collecting information, producing analytical studies, conducting consultations and preparing Draft Reports to contribute to the SLC program of work. In particular, the incumbent will:

- support in-depth analysis and critical reviews of the state of food and agriculture in Caribbean as the basis for advising on priority evidence-based food and agricultural policies and actions, and institutional, legal and regulatory reforms needed to drive the agricultural transformation agenda and rural development;
- provide economic analysis support to FAO national and regional Food and Nutrition Security Policies and Action Plans teams - made up of leading experts from universities, civil society, private sectors, public agencies, and policy think tanks and across Caribbean - to develop intervention strategies to drive the food and agricultural transformation agenda;
- provide analytical support for the determination of the economic impacts of agricultural policies on agricultural producers and consumers and how to sequence policy and institutional reforms to ensure successful implementation of the food and nutrition security transformation action plans;
- support the development of a clear policy advocacy action plan to effectively communicate the policy directions to drive the agricultural transformation agenda;
- support the building of strong policy advocacy networks for the successful implementation of food and nutrition security policies and action plans, through creating awareness and effectively communicating the Transformation Agenda to non-state actors, and ensuring that stakeholders are adequately informed of the relevant programmes;
- support the monitoring and evaluation of the implementation of the various food and nutrition security policies and action plans;
- support the preparation of policy briefs on issues of importance at the national and regional levels, policy briefs for the Food and Nutrition Security Councils and other relevant stakeholders;
- support the development and deepening of the internal policy institutional capacity within and outside of FAO;
- perform other duties as required.

#### MINIMUM REQUIREMENTS

*Candidates should meet the following:*

- Advanced university degree in economics or agricultural economics or related fields
- One year of relevant experience in micro economy (farm analysis), agricultural policy (formulation, evaluation), statistics-quantitative analysis, project management, agricultural development or , sustainable development
- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese or Russian

#### SELECTION CRITERIA

*Candidates will be assessed against the following:*

- Experience in food and agricultural development, food and nutrition security policy preferably in developing countries
- Ability to plan and organize own work, deliver results and meet deadlines
- Ability to work effectively within a team, supporting others and fostering a positive team environment
- Commitment to continual improvement of knowledge, skills and abilities
- Excellent oral and written communication skills
